On the morning of 21-4-45 he is at 4172164 (Sheet X-3) NW of Friedrichshafen

and a few km. S of the village of Deckingen. His travel paper authorizes him to travel from Freiburg to Heidenheim (N of Ulm) by way of Kempten, where he has 48 hours to visit his wife, who is evacuated there from Sagan.

His route therefore will be Friedrichshafen-Bregenz-Kempten-Memmingen-Ulm-Heidenheim.
