1. SOVIET AMBASSADOR TO HANOI ILYA S H C H E R B A K O B, SPEAK-  
 ING DURING A STOPOVER IN [REDACTED] OF THE [REDACTED] SEPTEMBER 1972 AEROFLOT  
 FLIGHT FROM HANOI TO MOSCOW, STATED THAT HE HEARD SHORTLY BEFORE DE-  
 PARTING HANOI THAT THE NORTH VIETNAMESE PLANNED TO RELEASE FIVE AMERI-  
 CAN PRISONERS OF WAR ON 2 SEPTEMBER 1972 AND THAT THE RELEASED PRISON-  
 ERS WOULD BE SENT TO VIENTIANE ABOARD THE INTERNATIONAL CONTROL COM-  
 MISSION FLIGHT OF EITHER 6 SEPTEMBER OR 13 SEPTEMBER 1972. [REDACTED]

[REDACTED] SHCHERBAKOV APPARENTLY DID NOT ELABORATE ON THE SOURCE OF HIS  
 INFORMATION. A 2 SEPTEMBER BROADCAST BY RADIO HANOI STATING THREE AMERI-  
 CAN PRISONERS WOULD BE RELEASED IN COMMEMORATION OF NORTH VIETNAM'S  
 NATIONAL DAY PROMPTED SPECULATION THAT THE PRISONERS MIGHT ARRIVE IN  
 VIENTIANE ABOARD THE 2 SEPTEMBER AEROFLOT FLIGHT. [REDACTED]

IN EXPEDITING THESE FLIGHTS TO THEIR DESTINATION, AND HE SUGGESTED THAT [REDACTED] SEND A MESSAGE TO HANOI VIA THE VIENTIANE AIRPORT RADIO STATING THAT IF THE PLANES WERE NOT GIVEN PERMISSION TO LAND IN HANOI THEY WOULD RETURN TO MOSCOW. HANOI WAS CONTACTED EARLY ON THE MORNING OF 3 SEPTEMBER 1972 AND AGAIN PERMISSION WAS DELAYED. AT 0800 HOURS ON 3 SEPTEMBER, APPROXIMATELY ONE HOUR AFTER THE SOVIET REQUEST WAS RELAYED TO HANOI, THE NORTH VIETNAMESE GAVE PERMISSION FOR THE AIRCRAFT TO DEPART AND THEY LEFT VIENTIANE AT ABOUT 0815 HOURS. [REDACTED] THE UNSCHEDULED LANDING IN VIENTIANE OF SOVIET PLANE AN-12 NO. 11120 ON THE AFTERNOON OF 31 AUGUST. THE OTHER PLANE WHICH DEPARTED VIENTIANE ON 3 SEPTEMBER, AN-12 NO. 11129 HAD BEEN ON THE GROUND SINCE 29 AUGUST.)
