SOURCE DOMINICAN GOVERNMENT OFFICIAL (F)

1. ACCORDING TO CESAR SAILLAN VALVERDE, FORMER PERSONAL SECRETARY TO GEN. RAFAEL (RAMFIS) L. TRUJILLO, JR., THE ASSASSINATION OF LUIS AMIAMA TIO AND ANTONIO IMBERT BARRERAS, MEMBERS OF THE DOMINICAN COUNCIL OF STATE, WHICH IS BEING PLANNED BY RAMFIS, WILL BE CARRIED OUT BY ROLANDO MASFERRER, FORMER CUBAN SENATOR AND WELL-KNOWN EXILE WHO IS NOW IN NEW YORK. VICTOR SUEZ, A PERSONAL SECRETARY TO RAMFIS IN PARIS, IS COORDINATING THE ASSASSINATION PLANS WITH MASFERRER. MASFERRER WILL USE FOUR CUBAN AGENTS IN THE ASSASSINATION ATTEMPT.

2. SINCE IT IS NOT KNOWN WHETHER THE CUBAN AGENTS ARE IN THE DOMINICAN REPUBLIC AT THIS TIME OR WHETHER THEY WILL GO THERE IN THE NEAR FUTURE, THE DOMINICAN GOVERNMENT HAS INCREASED ITS TRAVEL RESTRICTIONS ON CUBANS WHO TRY TO ENTER THE COUNTRY. SECURITY MEASURES HAVE BEEN INCREASED ALSO AT THE NATIONAL PALACE IN SANTO DOMINGO.

3. FIELD DISSEM: STATE, ARMY, NAVY, AIR, CINCLANT, CINCARIB.

4. HEADQUARTERS COMMENT: ACCORDING TO A USUALLY RELIABLE SOURCE, PRESIDENT BONNELLY, AMIAMA, AND IMBERT ARE WORRIED ABOUT REPORTS OF PLOTTING BY JOSE ARISMENDI (PETAN) TRUJILLO, A BROTHER OF THE LATE DICTATOR, AND RAIFIS AGAINST THE COUNCIL WHICH INVOLVES THE ASSASSINATION OF GOVERNMENT OFFICIALS. BONNELLY BELIEVES THAT HE WILL BE INCLUDED IN ANY ASSASSINATION ATTEMPT. BONNELLY, AMIAMA, AND IMBERT ARE NOT CONCERNED THAT THEY WILL BE AMBUSHED AS THEY ALWAYS TRAVEL HEAVILY GUARDED. HOWEVER, THEY BELIEVE THAT THE ATTEMPT WILL INVOLVE AN EXPLOSIVE CACHE - POSSIBLY IN AN AUTOMOBILE - WHICH WILL BE TRIGGERED BY AN ELECTRONIC SIGNAL SUCH AS THAT USED BY THE DOMINICAN SERVICIO DE INTELIGENCIA MILITAR (SDM) IN ITS ATTEMPT ON THE LIFE OF PRESIDENT ROMULO BETANCOURT OF VENEZUELA. BONNELLY, AMIAMA, AND IMBERT BELIEVE THE ASSASSINATION ATTEMPT IS LIKELY TO OCCUR ON OR BEFORE 30 MAY 1962. SEE REFERENCES ..
