- He stated that for the past year he has seen or been in the President's company on an average of "not more than once every three or four months", not including the boat trip in February. Furthermore, that he was not in agreement with his execution of the agrarian reform, although he believed in the reform in principle, and felt that his views on the matter not only would not have any effect on \sqsubset ☐ but might provoke a difference or dispute between the two wnich he was not willing or desirous of having. For the aforementioned reason he created a "mental block" viz-a-viz 3 actions and policies and declined to rationalize or discuss them with anyone except \sqsubset He further stated that his views had undoubtedly been communicated to Arbenz in an innocent endeavor to be constructive by 7 inasmuch as Arbenz evaded becoming involved in any conversations With nim on the recent boat trip concerning controversial subjects as though he was completely aware of his feelings, was not in agreement with them and did not want to discuss them.

After our ascertaining that \(\begin{align*} \sqrt{1} \) vas aware of the Communist influence in the government and that he felt that there was a great need to follow their activities, a request was made to have him cooperate and furnish intelligence information which he flatly refused, then reconsidered and placed his consent in abeyance to give him time to think the proposition over. He did state however that he would be willing to go to Arbenz upon his return and give him his views on the reaction of the current public opinion in the United States the Guatemalan situation, i.e., that Arbenz personally is well liked but is being completely dominated and influenced by the small Communist minority who are in turn receiving their instructions from Moscow; that the Guatemalan foreign policy, particularly their relationship with the United States and other Western powers, is dictated by the Communists and serves flone but Russia and is designed to place Guatemala in such an intransigent position that it

will result





will result in a chaotic internal and foreign policy which will allow the Commies to solidify their gains, with the possibility of usurpation of the government itself, and that after the Communist influence has been removed, all differences between the countries become secondary and easily solvable.
