1. REGRET YOU HAVE NOT RECEIVED FULL BRIEFING ON PBSUCCESS. HOWEVER IT IS AN EXTREMELY DIFFICULT OPERATION INVOLVING SEVERAL COUNTRIES AND MANY STRONG CROSS CURRENTS. IT IS PATENTLY IMPOSSIBLE AND UNDESIRABLE TO KEEP ALL [] FULLY INFORMED THEREFORE LINCOLN UNDER HQS MUST REQUEST ACTIONS AT TIMES WHICH MAY NOT BE ENTIRELY CLEAR TO EACH STATION.

2. IN CONFORMITY REQUIREMENT TO KEEP ODOYKE AS ALOOF AND CLEAR AS POSSIBLE FROM INVOLVEMENT IN PBSUCCESS, IT IS DESIRED TO MINIMIZE ALL OPERATIONS CONDUCTED BY YOUR STATION DURING THIS TIME TO GIVE IMPRESSION NON-PARTICIPATION.

I. PREFER IF PRACTICABLE CONTACT BE MADE BY [] AS MATTER LESS CONSPICIOUSNESS. INITIAL CONTACT SHOULD BE TELEPHONE SAYING "I WAS ASKED TO CALL YOU BY A FRIEND OF MINE IN STATES NAMED ED BAKER WHO SAID HE WAS FRIEND OF YOURS." THIS SHOULD FOLLOW BY NORMAL ARRANGING TO MEET.
