1. YOUR PROPOSAL IN REF A TO OBTAIN CHINCHILLA'S QUOTE COOPERATION UNQUOTE IS EXCELLENT, AND THE METHOD PROPOSED IN REF B IS A SOUND APPROACH IF MA BUILDS UP SUSPENSE AS TO PENALTIES FOR NON-COOPERATION AND POSSIBLE BENEFITS FOR COOPERATING.

2. IF WSBURNT MA GETS FAVORABLE RESPONSE FROM THE AMBASSADOR, SUGGEST THAT YOU EXPAND AMBASSADOR'S REVELATIONS THROUGH MA, TO INCLUDE ALL SUBJECTS LISTED IN PARA 3A THROUGH 3E OF REF B EXCEPT THAT RESPONSIBILITY FOR RIOTS TEGU MENTIONED IN 3B WOULD BE ATTRIBUTED SIMPLY TO WSBURNT. PUBLICATION OF REVELATIONS SHOULD BE CAREFULLY PLANNED AND TIMED TO GET MAXIMUM IMPACT. KUBARK WOULD BE GLAD TO ASSIST IN <sup>EXPLOITATION</sup> ~~EXPLOITATION~~ AND DISSEMINATION.

3. AMBASSADOR'S REVELATIONS AT THIS TIME CAN BE PUBLICLY JUSTIFIED BY STATEMENT THAT NEFARIOUS WSBURNT ACTIVITIES IN WSHOOF'S WERE CARRIED OUT THROUGH
