FOLLOWING INFO FURNISHED TO IDEN A BY IDEN B AFTERNOON 21 MAY: IDEN B HAS BEEN DIRECTLY INVOLVED IN PLANTING CASES ARMS, AMMO AND LIGHT FIELD PIECES IN KNOCKDOWN CONDITION STRATEGIC POINTS IMMEDIATE VICINITY BANANERA. ALL WEAPONS ARE PBPRIME AND ALL CRATES BEAR MARKINGS []. IDEN B WORKING WITH TEAM INVOLVED PROVIDING WSBURNT GOVT WITH FAKE AFFIDAVITS, DEPOSITIONS TAKEN FROM INDIVIDUALS POSSIBLY NOTIONAL WHO SWEAR THEY ARE ENGAGING SEDITIOUS ACTIVITIES AGAINST WSBURNT GOVT. IDEN A PERSONALLY SAW FAKE SURVEILLANCE REPORT HIS ACTIVITIES WHICH INDICATES HE HAS MET CUBAN PLANES FOR PURPOSE ACCEPTING INSTRUCTIONS ETC.

2. IDEN B SAYS WSBURNT GOVT INTENDS "DISCOVER" ARMS WITHIN 30 DAYS, CONDUCT MOCK INVESTIGATION, EXHIBIT AFFIDAVITS, DEPOSITIONS AND INVITE MEMBERS DIPLOMATIC CORPS ASSIST DIGGING UP AND UNCOVERING HIDDEN ARMS. DURING RESULTING PUBLICITY WSBURNT GOVT WILL VIOLENTLY
