A. Your para A. In spite of my 1098 I think I can cancel scheme.

- B. Your paras B. & D. re.LIZARD. I informed you in my 0953 that LIZARD had already raised total of 190,000 repeat 190,000 before latest departure from Denmark. Of this sum 95,000 repeat 95,000 was originally paid to ZEBRA and further 90,000 repeat 90,000 handed to ZEBRA in August. Remaining 5,000 repeat 5,000 retained by LIZARD with my approval for expenses in connection with his various activities on our behalf. Will confirm with PORGY when he arrives that latest sum of 90,000 repeat 90,000 already received by him. It is almost certain that further sum of 200,000 repeat 200,000 already raised by ZEBRA and paid to PORGY. It will not repeat not be possible cancel this.
- C. Your para C. My 1060 para D informed you that bulk of PLATE's 190,000 repeat 190,000 paid in early June repeat early June. This sum should therefore be considered spent by now. It is more likely that this sum of PLATE's is the "local donation" referred to by JULEP.
- D. JULEP knew about MACARONI and so did PORGY and HORSE.
- E. Can not repeat not understand your reference to MACARONI funds received via Freedom Council. I outlined MACARONI proceedure in detail in my D.1098. On other hand PLATE's money almost certainly went through Freedom Council.
- F. Your para H. I know nothing of this transaction at present. Will ask PORGY.
- G. Assuming (a) MACARONI money has been taken over by PORGY's successor (b) we can reduce LIZARD's transaction from 500,000 repeat 500,000 to 290,000 repeat 290,000

(including) all sums raised by LIZARD and ZEBRA except original 100,000 repeat 100,000) we should have total of 688,000 repeat 688,000 in hand to cover next three months. This estimate is not exact since LIZARD may be able to reduce his transaction still further and transaction

- able to reduce his transaction still further and transaction mentioned in my D.1377 pera.3 not repeat not included.

 H. Our only further commitments should be to (a) LIZARD and ZEBRA 250,000 repeat 250,000. That is to say 290,000 repeat 290,000 less 40,000 repeat 40,000 already credited or reimbursed to HOLLESEN. See my D.1223. (b) HEMPEL and his boys 200,000 repeat 200,000. That is to say 190,000 repeat 190,000 plus 10,000 repeat 10,000 mentioned in my 1060 para G.
- I. Full details of (b) follow in my D.1377 in today's bag. I am delaying final written report on (a) until PORGY arrives and we get full details.
- J. PORGY statement attached to your D.518 should therefore be amended as follows:-
 - (a) RECEIPTS should be reduced by 210,000 repeat 210,000 in ZEBRA's name and by 500,000 repeat 500,000 under "local Donations.(6) Receipts should be increased by 13,000 repeat 18,000 under MACARONI and by 10,000 repeat 10,000 under HORSE. Result is over-all reduction of 682,000 repeat 682,000 crowns.
- K. In proposing sudden alterations in SETTEE please remember that in raising funds our friends are risking their lives and that present extremely difficult conditions in Denmark make it dangerous for them to pay money back or cancel transactions already laid on. I consider it would be preferable to be left with large reserve after liberation than to expose friends in field to unreasonable risks now by insisting on cancellation of transactions already carried out. Such insistance might result in "blow ups" leading to destruction of entire organization.
