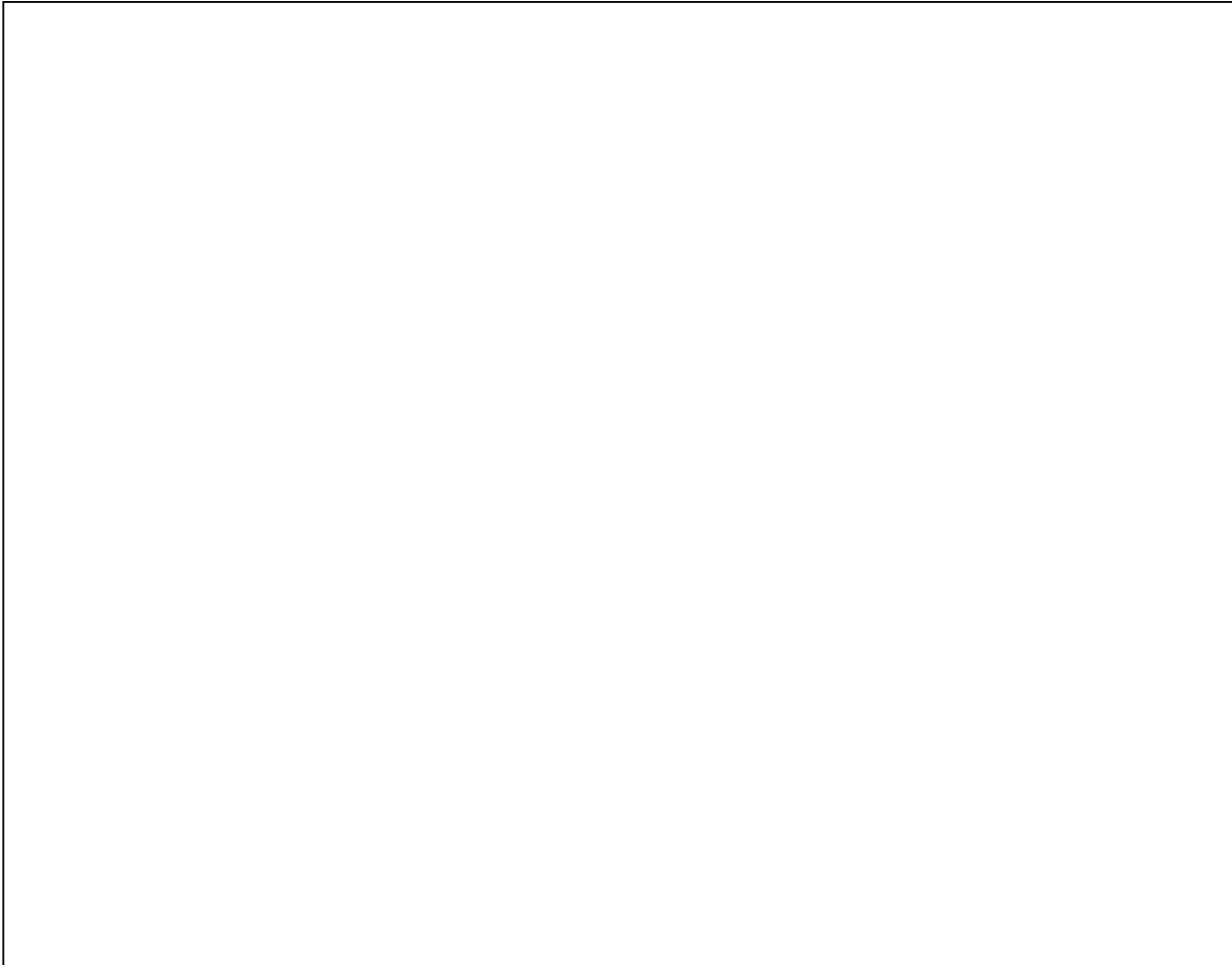
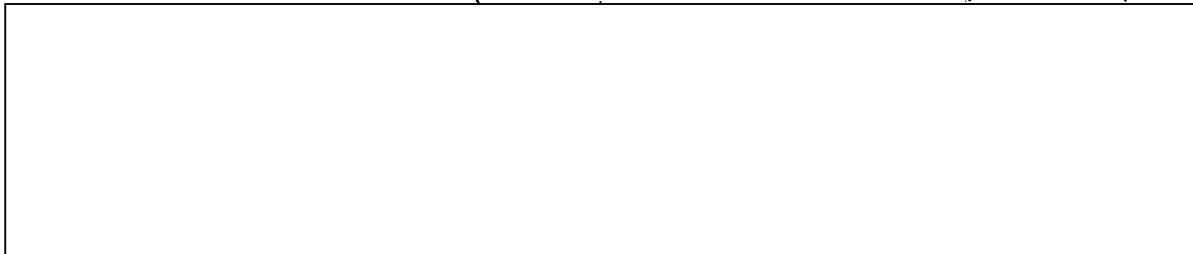

CHANGE IN CAREER INTENTIONS OF

1. SUMMARY: [REDACTED] OFFICER [REDACTED] AND [REDACTED] OFFICER
[REDACTED] MET WITH [REDACTED] [REDACTED] FOR 2 1/2 HOURS EVENING 31 AUG
AT S/H PAUL. NO SECURITY PROBLEMS WERE NOTED AND A WIDE RANGE OF

TOPICS WERE COVERED DURING THE COURSE OF THE MEETING, WHICH WAS CONDUCTED PRIMARILY IN ARABIC WITH FREQUENT BUT LIMITED UTILIZATION OF ENGLISH, WHICH P/1 SPEAKS AT ABOUT THE -2 LEVEL. THE MOST IMPORTANT ISSUE CLARIFIED WAS THE EMPLOYMENT STATUS AND PERSONAL CAREER ASPIRATIONS OF P/1. IN SHORT, P/1 ADAMANTLY STATED THAT HE HAS NO INTENTION TO RETURN TO THE SERVICE OF THE ESO AND IS PRESENTLY CONTEMPLATING AN OFFER TO JOIN THE "OPERATIONS DEPARTMENT" OF THE REVOLUTIONARY COMMITTEES (RC) IN TRIPOLI. WE ARE DISAPPOINTED WITH THIS APPARENT REVERSAL OF INTENTIONS ON P/1'S PART AND WILL NOW CONSIDER OTHER OPTIONS FOR OUR FUTURE RELATIONSHIP.

2. STATUS WITH ESO: P/1 EXPLAINED THAT HE PERSONALLY MET WITH SENIOR ESO OFFICER AHMAD ((QADAF)) AL-DAM TWICE IN TRIPOLI SHORTLY AFTER HIS RETURN TO LIBYA IN EARLY JUNE 1989. AT THE FIRST MEETING, P/1 REQUESTED PERMISSION TO PROCEED WITH HIS OFFICIAL WRITTEN REQUEST, SUBMITTED FROM MALTA IN MAY, TO BE PLACED ON "SICK LEAVE STATUS" DUE TO HIS WELL-DOCUMENTED ARM SURGERY PROBLEMS. QADAF AL-DAM INFORMED P/1 THAT THE REQUEST WOULD BE GRANTED, HOWEVER, P/1 WOULD BE PLACED ON A STATUS WITHOUT PAY. P/1 THEN MET WITH SENIOR RC MEMBER ALI ((KILANI)) WHO OFFERED HIM A POSITION IN THE "OPERATIONS ROOM" OF THE RC HEADQUARTERS IN TRIPOLI. P/1 BELIEVES THAT SUCH A POSITION WOULD PERMIT HIM TO MAKE PERIODIC TDY'S THROUGHOUT AFRICA AND EUROPE ON RC "BUSINESS." IN P/1'S OPINION, THE RC IS MUCH MORE POWERFUL THAN THE ESO AND HE WOULD THUS HAVE BETTER "ACCESS" TO INFORMATION OF "VALUE" TO [REDACTED] P/1 TENTATIVELY ACCEPTED KILANI'S JOB OFFER AND WILL MEET WITH HIM AGAIN IN OCTOBER WHEN IT IS EXPECTED THAT HIS ARM WILL BE IMPROVED, ALLOWING HIM TO RETURN TO ACTIVE WORK STATUS. P/1 MET FOR A SECOND TIME WITH QADAF AL-DAM AND OFFICIALLY ADVISED HIM THAT HE ACCEPTED THE TRANSFER TO LEAVE WITHOUT PAY STATUS AND THAT HE WAS CONSIDERING OTHER CAREER OPTIONS OUTSIDE THE ESO.



4. FINANCES: P/1 REQUESTED REIMBURSEMENT OF 1,000 LM FOR A SECOND OPERATION ON HIS ARM. P/1 ALSO REQUESTED REIMBURSEMENT OF 500 LM FOR 20 DAYS OF HOTEL, CAR RENTAL AND PER DIEM EXPENSES ENCOUNTERED ON THIS TRIP TO MALTA. [REDACTED] OFFICER [REDACTED] PLANS TO PROVIDE THE ABOVE FUNDING TO P/1 AT MEETING ON 4 SEPT IN ADDITION TO \$5,000 SALARY OWED P/1 THROUGH AUGUST 1989. P/1 WILL

BE ADVISED, IN NO UNCERTAIN TERMS, ON 4 SEPT THAT WE WILL NOT PROVIDE ANY ADDITIONAL FINANCIAL ASSISTANCE FOR OPERATIONS ON HIS ARM. P/1 WILL ALSO BE TOLD THAT WE WILL ONLY CONTINUE HIS \$1,000 PER MONTH SALARY PAYMENT THROUGH REMAINDER OF 1989. IF P/1 IS NOT ABLE TO DEMONSTRATE SUSTAINED AND DEFINED ACCESS TO INFORMATION OF INTELLIGENCE VALUE BY JANUARY 1990, [] WILL CEASE ALL SALARY AND FINANCIAL SUPPORT UNTIL SUCH ACCESS CAN BE PROVEN AGAIN.

5. P/1'S CAVEAT ON COOPERATION: DURING COURSE OF DISCUSSIONS ON [] P/1 BECAME SOMEWHAT DEFENSIVE, AND CLARIFIED HIS CONDITIONS FOR COOPERATING WITH [] P/1 STATED THAT HE NEVER INTENDED TO BECOME A "SPY" FOR [] AND THAT HE DESPISED SPYS, AND THAT WAS WHY HE WANTED OUT OF THE ESO. P/1 STATED CLEARLY, AND WITH EMOTION, THAT HE WILL ONLY REPORT ON TERRORIST-RELATED INTENTIONS AND ACTIVITIES OF THE ESO AND THAT HE WILL NEVER REPORT ON ROUTINE GOVERNMENT OR MILITARY DEVELOPMENTS. P/1 STATED THAT HIS INTENTIONS HAVE BEEN CLEAR FROM THE BEGINNING AND HE WAS NEVER GOING TO CHANGE.

6. ASSESSMENT: IT IS CLEAR THAT P/1 WILL NEVER BE THE PENETRATION OF THE ESO THAT WE HAD ANTICIPATED. P/1 IS NOW OUT OF THE ESO AND HAS NO INTENTION TO ATTEMPT TO REGAIN DIRECT ACCESS. UNFORTUNATELY, IT APPEARS THAT OUR ASSISTING HIM IN SCAM SURGERY ON HIS ARM TO AVOID MILITARY SERVICE HAS HAD THE REVERSE RESULT THAT WE HAD INTENDED. IT HAS ALSO ALLOWED HIM TO AVOID FURTHER SERVICE WITH THE ESO, P/1'S TRUE INTENTION FROM THE BEGINNING. P/1 HAS NEVER BEEN A TRUE STAFF MEMBER OF THE ESO AND AS HE STATED AT THIS MEETING, HE WAS COOPTED WITH WORKING WITH THE ESO AND HE NOW WANTS NOTHING TO DO WITH THEM OR THEIR ACTIVITIES. P/1 WOULD PREFER TO REMAIN ON MALTA.

7. PLANS: WE CLEARLY ARE NOW FACED WITH TWO OPTIONS:

A. WAIT THE REMAINDER OF 1989 AND SEE WHAT POSITION OF ACCESS P/1 IS ABLE TO DEVELOP WITHIN THE RC. WE ARE UNCERTAIN WHAT A POSITION WITHIN THE "OPERATIONS ROOM" WILL PROVIDE P/1 ACCESS TO, ONLY TIME WILL TELL. REQUEST HQS ADVISE DETAILS CONCERNING RC "OPERATIONS ROOM" ACTIVITIES AND ASSESSMENT OF POTENTIAL FOR FUTURE REPORTING VALUE.

B. ENCOURAGE P/1 TO RETURN TO MALTA AND ESTABLISH FRONT COMPANY FOR PERIODIC USE BY ESO OPERATIVES ON MALTA. P/1 MIGHT POSSIBLY AGREE TO SUCH A PROPOSAL IF WE PROVIDED HIM WITH REQUIRED FUNDING. WE ARE UNCERTAIN HOW MUCH IT WOULD COST TO SET P/1 UP OR EVEN WHAT LEVEL OF ACCESS SUCH AN OPERATION WOULD ALLOW. WE HAVE NOT DISCUSSED THIS OPTION WITH P/1 YET BUT WELCOME HQS VIEWS.

8. NEXT MEETING: [] OFFICER [] AND [] DOCTOR WILL MEET WITH P/1 ALONE EVENING 4 SEPT. DISCUSSIONS WILL BE LIMITED DUE TO LANGUAGE PROBLEMS, HOWEVER, WE BELIEVE IT BEST TO LIMIT UTILIZATION OF T/1, AS IT IS CLEAR THAT P/1 DISCUSSES ISSUES MORE OPENLY AND CLEARLY WHEN ALLOWED TO SPEAK IN ARABIC WITHOUT PRESENCE OF T/1 SERVING AS TRANSLATOR. P/1 THINKS HE MAY BE DEPARTING ON 7

SEPT, HOWEVER, HE REMAINS UNEMPLOYED UNTIL OCTOBER AND COULD POSSIBLY REMAIN ON ISLAND LONGER. FOLLOWING HQS, [REDACTED] AND [REDACTED] DIGESTION OF ABOVE DEVELOPMENTS, FURTHER DISCUSSIONS BETWEEN [REDACTED] AND P/1 ABOUT PARA 7 OPTIONS WILL BE IN ORDER FOLLOWING HIS RETURN TO LIBYA AND CLARIFICATION OF STATUS. WE WILL WANT TO ENSURE THAT P/1 UNDERSTANDS WHAT IS EXPECTED OF HIM AND WHAT HE CAN EXPECT FROM US IN RETURN. [REDACTED] OFFICER [REDACTED] WILL THEREFORE ADVISE P/1 AT 4 SEPT MEETING THAT HE IS ON "TRIAL" STATUS UNTIL 1 JANUARY 1990. P/1 WILL BE INSTRUCTED TO MAKE EVERY EFFORT POSSIBLE TO RETURN TO MALTA IN OCTOBER TO DISCUSS FURTHER DEVELOPMENTS AND TO ADVISE RE HIS EMPLOYMENT STATUS. [REDACTED] WILL THEN BE ABLE TO CLEARLY EXPLAIN OUR COLLECTIVE JUDGMENT REGARDING FUTURE OBJECTIVES.
