

Please include any surveillance where one of the parties may have consented to the surveillance, as well as any surveillance conducted pursuant to Title III of Public Law 90-351 as amended by Public Law 99-508. The time period for which the search is sought is April 19, 1993, through July 17, 1996. We have enclosed additional information concerning the individuals for your use in responding to this request.

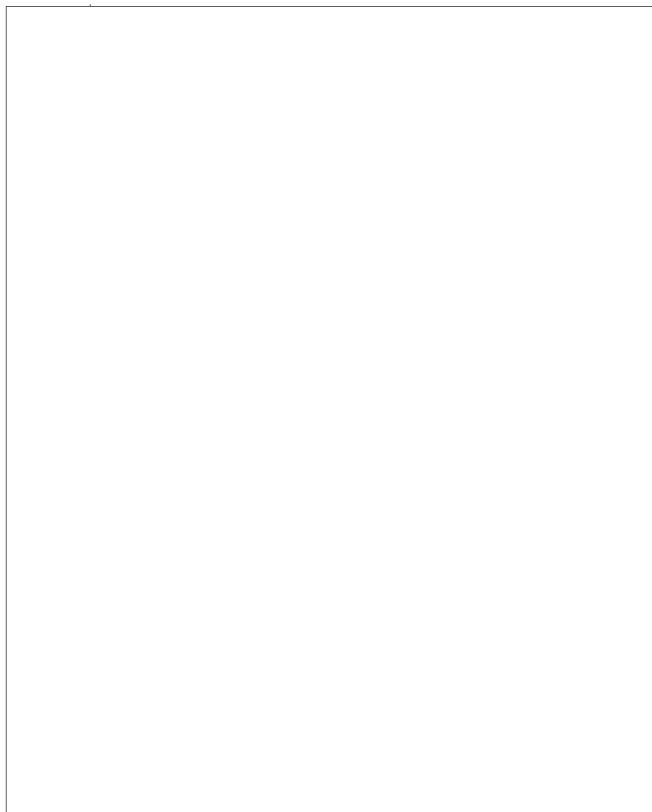
