c. GCDLER asked what Frofessor Miroslav LAROS has been doing in Germany. Source told him VAROS had visited Stattgart (M1405), GFR, where he met with Niko MOVACIO to discuss the plans for writing and printing a newspaper and other anti-Yugoslavian propaganda. VAROS also went to Meunkirchem (LV6767), GFR, to speak with Franjo FAVECIO about the propaganda material and also about the pending meeting of the Hrvatski Demokratski Ogbor (Groatian Democratic Committee) (HDO) which is to take place in Frankfurt/Main. VAROS came to Frankfurt/Main, where he met with Source and discussed the upcoming meeting of HDO. VAROS told Source to arrange for a meeting place. The meeting had been socheduled for 20 and 21 February, but has been postponed to 27-28 February. GODLER told Source to do his utmost to get himself elected to the leadership of the HDO if elections were held at the meeting. GGDLER asked if Source had obtained a place to the the meeting. Source said he had not found a place to hold the meeting as yet.. GODLER asked if Source would be able to take a tape recorder with him and secretly record the meeting. Source said he could not tell yet as he still did not know where the meeting would be held. GODLER told Source they would have to meet again before the HDO meeting was held, in order to determine if the tape recorder could be placed in the meeting room.

d. GODLER asked which members of the Hrvatski Revolucionalno Bratstvo, (Croatian Revolutionary Brotherhood) (HRS), from Stattgart would be coming to the HDO meeting in Frankfurt/Main. Source said be did not know yet as PAYEOIC would make the invitations to the HES and RAYEOIC has not spoken with Source about the meeting, CODLER asked whether/Gene/PASTI was coming to the meeting, but Source said he did not know. CODLER them said he was going to make trouble for PASTI through the German officials, and strengt to get PASTI throw out of the country, because he was sure to cause trouble to the Yugoslavian government if allowed to operate freely in Mest Germany.

The Dool GODLER said he knew Jure WILDYAU had come to Frankfurt/Main and had seen Source. He asked Source what WILDYAU was doing in Frankfurt/Main. Source told him MILDYAU had just come through on his way to visit PAVECIC in Meunkirchen. While he was here he had not with Source and spoken briefly about the meeting of the HDO to be held soon in Frankfurt/Main.

f. GODLER asked if Source had visited Jure PEZELIC or Sulejman GLABUS.
Elource said he had written letters to both these sen indicating he would like to see them, but to date has not received any answer from them. Source said he would very likely see both these sen at the upcoming EDO meeting.

g. GODLER asked if Source has written to or heard from Krumoslav
DRAGOMOVIC recently. Source said he had sent DRAGOMOVIC a card at Christmas,
But had had no further communication with him. Source gave GODLER DRAGOMOVIC'S
phesent address, a monastary near Vienna (noa) Austrias Sacre Coeur, Pressbaum
bel Wien, Cesterreich, Telephone 427, GODLER asked what DRAGOMOVIC is doing
now and Source said he is working on a history of some sort and as far as Source DRAGOMOVIC is no longer active politically.

h. GODLER maked if Source's family in Inguslavia had applied for a visa to visit West Germany. Source said they had, but had been turned down. GODLER said he had wired instructions that the visas were to be issued, but evidents: ly there had been some mixup. GODLER said he would wire further instructions and told Source to advise his family to reapply for the visas.

i. The meeting lasted until approximately 2000 hours, GODLER set the date of the next meeting for 26 February 1965, at 1800 to 1815 hours at the Boersenkeller Restaurant, Frankfurt/Main. GODLER told Source to return to Frankfurt/Main by himself as someone was coming to pick GODLER up later. Source returned to Frankfurt/Main by bus. So payments were made to Source by GODLER.
