SUBJECT: IAF Budget for FY-1958

This memorandum is for information only.

1. After Brayton Wilbur and Bob Blum made their budget plea to you on June 4 we went over IAF's budget request for FY-1958 in detail with Bob Blum. As a result, I concluded (a) that a slight increase in the \$[] figure we had given Blum would still leave him with a tight budget and (b) that it would be psychologically beneficial to enable Bob to return to San Francisco with added evidence of our confidence in him. Therefore I told Bob that after careful review and revision of IO Division's budget for next year I would be able to increase his budget by [] to [], subject of course to your approval and the Congressional appropriation for the Agency. Actually, the [] will come from a TAF reserve we had planned to hold in IO Division, without Blum's knowledge, because of our certainty that Blum would come in for a supplemental appropriation about six months from now.

2. Blum was grateful for the extra [], though of course he would like more. He is now going to revise his budget request on the basis of a ceiling of []. I believe that Brayton Wilbur and the Board of Trustees will not put further pressure on you about the budget at this time.
