1. While visiting his mother for TET [redacted] on 30 January 1968, [redacted] heard that Viet Cong (VC) had come to the village. He immediately boarded a bus at 1200 hours. VC stopped the bus along Route 5, and abducted [redacted] and 12 other people. The VC then led them to a village whose name [redacted] did not know, where a 200-man VC group was quartered. [redacted] saw rifles, but did not know their make. The 200-man unit moved out on 31 January with [redacted] and the 12 other impressed people carrying the ammunition in wooden boxes. The group moved to the PHU DINH area.

2. On arrival there, the ammunition bearers were told to evacuate the wounded to a village between the RACH CAT Road and PHU DINH. They made seven trip, each man carrying a wounded soldier per trip. At 0400 hours, 1 February as [redacted] began his eighth trip, government of Vietnam (GVN) aircraft bombed the PHU DINH area.
