He-entered Engoalavia, where the severence of relations between Tite and Comminform had created a strong public feeling against the Balgarian Government. SUBJECT was originally kept under surveillance in Yugeslavia but he was later allowed to work as a miner in a chremium mine at Radase, Georgipetrafike.
