14. ENDO, SABURO I I ON 5 MARCH 1961, SUBJECT MET WITH ENDO AT THE SUEHIRO RESTAURANT IN GINZA, TOKYO. SUBJECT INFORMED ENDO THAT THE SOVIET MILITARY ATTACHE'S OFFICE HAD FAILED TO DEVELOP INFORMANTS AMONG STAFF MEMBERS OF THE GROUND, MARITIME, AND AIR SELF-DEFENSE FORCES OF JAPAN. SUBJECT FURTHER ADVISED THAT HE INTENDS TO SELECT FORMER MILITARY MEN, WHO MAINTAIN CLOSE RELATIONS WITH THE NATIONAL DEFENSE AGENCY AND THE JAPAN SELF-DEFENSE FORCES, AS INFORMANTS. /SOURCE: OSI/. ON 23 FEBRUARY 1962, ENDO AND THREE OTHER OFFICIALS OF THE EX-MILITARISTS JAPAN-COMMUNIST CHINA AMITY SOCIETY /SHIMODA NOBORU, GOTO SETSURO AND OKABAYASHI TATSUYUKI/ ATTENDED THE RED ARMY COMMEMORATION CELEBRATION HELD AT THE SOVIET EMBASSY.
