3. While we have no reason to credit the above allegations, it is conceivable that the Soviets may become aware of them and choome to use them against CASPEERE. The records available to us do not substantiate the information in para 1 above although the para 2 material could possibly have a bearing on this allegation. Because Identity-3 was allegedly CASPEERE's collaborator on the plan in para 1 above, we think it possible that Field and Head-quarters traces on Identity-2, with appropriate biographic data supplied by the Field, may shed some light on the present information. We do not have enough information to trace Identity-3 and therefore suggest that the Field can gain pertinent information through a check on Identity-3 who is said to reside in Wetzlar.

4. We would also appreciate your querying on the general subject of CASPHER's activity during WW II with special attention to any economic functions performed for the Ministry Affairs of the Third Reich. In discussing this with defer to the Field as to how much detail should be provided him. We shall await the results of your action.
