ALERT AND THAT WHILE IT MAY HAVE BEEN NADNESSS TO EMBARK UPON ERHARD DEFAMATION CAMPAIGN THERE WAS CERTAINLY METHOD IN IT.) IT WILL BE RECALLED THAT ADENAUER REVERSED HIMSELF ON PRESIDENCY ONLY WHEN HE REALIZED HE WOULD NOT BE ABLE NAME. HIS SUCCESSOR AS HAD BEEN PROMISED BY COU PARLIAMENTARY LEADERS. PROSPECT ERHARD AS CHANCELLOR SO ABHORRENT TO ADENAUER THAT HE CHOSE ONLY RECOURSE OPEN TO HIM, NAMELY TO REMAIN CHANCELLOR. WE BELIEVE ADENAUER STILL INTENDS FINISH OFF ERHARD, REGARDLESS OF CONSEQUENCES TO HIMSELF OR PARTY AND THAT HE REGARDS LETTER OF APOLOGY TO ERHARD MERELY AS TEMPORARY EXPEDIENT FORCED UPON HIM BY PARTY LEADERS.

B. ADENAUER EFFORTS DENIGRATE ERHAND HAVE BEEN NOTABLE SUCCESS. FOR CHANCELLORSHIP MOTE ACTIVELY. COMING MONTHS WILL WITNESS EMERGENCE SERIOUS RIVALS TO ERHARD CANDIDACY AND IT NOT UNLIKELY ONE OR MORE OF THESE WILL OVERSHADOW ERHARD BEFORE NEXT ELECTIONS. IF ADENAUER ABLE TO SURVIVE AND WIN 61 ELECTIONS, IT MAY BE ASSUMED THAT ERHARD WILL NOT BE HIS SUCCESSOR.

- C. WHILE ADENAUER HAS AGAIN EMERGED KING OF CDU JUNGLE, IT NOT WITHOUT GRAVE AND PROBABLY IRREPARABLE DAMAGE TO HIS PERSONAL ANTHORITY WITHIN COU AND LOWERED PRESTIGE WITH GERMAN PUBLIC. FOR FIRST THE IN HIS POST-WAR CAREER, COU PARLIAMENTARY DELEGATION HAS SUCCESSFULLY, IF CHIEF TEMPORARILY, SUBJECTED HIM TO PARTY DISCIPLINE AND PUBLICLY CRITICIZED HIS JUNCHENT AND METHODS. - E. AS MENTIONED ABOVE, ADENAUER OBJECTION TO ERHARD PRIMARILY
 PERSONAL, EVEN THOUGH HE OFTEN CHOOSES EXPRESS HIS OPPOSITION IN TERMS ERHARD
 FIALURE PROVIDE ADEQUATE SUPPORT FOR COMMON MARKET AND OTHER EUROPEAN
 INTEGRATION INSTITUTIONS AND POLICIES. OVER THE YEARS AND PARTICULARLY IN

ANGLO-GERMAN RELATIONS. FIRST SPECIFIC SSUE VILL BE FTA VERSUS COMMON MARKET. INCLUDED AMONG COU POLITICIANS WHO HAVE ADOPTED ERHARD POSITION ON FTA AND DEMAND FOR BROADER FEDREP ECONOMIC HORIZONS THAN COMMON MARKET ARE MANY WHO SINCERELY CONCERNED ABOUT DETERIORATION ANGLO-GERMAN RELATIONS AND WISH SEE POSITIVE HEASURES FOR IMPROVEMENT, BUT ERHARD GROUP WARRANTS CLOSE ODYOKE OBSERVATION BECAUSE THERE ARE OTHERS WHO REGARD THIS AS INPPORTUNITY UNDERHINE AND REVISE ADENAUER FOREIGN POLICY OF WHICH FEDREP INTEGRATION INTO EUROPEAN AND NATO COMMUNITIES IS FUNDAMENTAL PRINCIPLE.
