Pursuant to the Freedom of Information Act ("FOIA"), 5 U.S.C. § 552, et seq., I am requesting any and all records, regardless of format, medium, or physical characteristics, and including electronic records and information, audiotapes, videotapes, and photographs, between the Central Intelligence Agency, its agencies, offices, and components, and the following individuals:

3. U.S. Senator John McCain
4. New Mexico Governor Bill Richardson

I seek records of any kind, including but not limited to, correspondence, memoranda, reports, statements, calendar or diary logs, telephone records, folders, files, forms, charts, and information about meetings and/or discussions as well as any electronic mail, notes, and agendas related to these meetings and/or discussions.

Using the two hours of free search time and 100 pages of free duplication to which I am entitled, please search responsive records, regardless of format, medium, or physical characteristics. Where possible, please produce the records electronically, in PDF or TIF format on a CD-ROM, particularly if providing the information in such a way reduces the time or expense involved. If electronic records are not available, I expect to receive the requested information in hard copy.

If any responsive record or portion thereof is claimed to be exempt from production under the FOIA, please provide me with an index of those documents as required under Vaugh v. Rosen, 484 F.2d 820 (D.C. Cir. 1973), cert. denied, 415 U.S. 977 (1972). Additionally, please cite each specific exemption that you believe justifies your refusal to release the information and inform me of your agency's administrative appeal procedures available to me under the law. In the event that some portions of the requested records are

properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records.

For your information, please note that I am a third-year student at George Washington University, gathering information for research purposes only. This information will not be used for commercial activities.

Please respond to this request in writing within twenty (20) business days as required under 5 U.S.C. § 552(a)(6)(A)(I). If all of the requested documents are not available within that time period, I request that you provide me with all requested documents or portions thereof that are available within that time period.

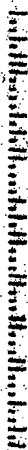
