3.3(b)(1), ([Redacted] COMMENT: ELENA HOLMBERG, AN ARGENTINE FOREIGN MINISTRY OFFICIAL WHO RECENTLY RETURNED FROM FRANCE WHERE SHE WORKED IN THE CULTURAL AFFAIRS SECTION OF THE ARGENTINE EMBASSY, WAS KIDNAPPED ON 20 DECEMBER 1978. ON 11 JANUARY 1979, A BODY REPORTED AS BEING THAT OF HOLMBERG WAS RECOVERED FROM THE LUJAN RIVER. THE PRESS REPORTED THAT AUTOPSIES PERFORMED ON THE BODY ESTABLISHED THAT DEATH HAD OCCURRED WITHIN 48 HOURS OF HER ABDUCTION. HOLMBERG WAS A NIECE OF FORMER PRESIDENT ALEJANDRO LANUSSE. HER BODY LAY IN STATE IN THE FOREIGN MINISTRY PRIOR TO BURIAL AND THE CASE HAS RECEIVED WIDESPREAD PUBLICITY. [Redacted]
