The appearance of the former General of the 3, 3, dilli HOTTL, who under the name of HAGEN had published the book, "The mar of the Spics", ampears in a not very favorable light because of his attempts to cause injury to HEINZ in a disloyal manner; HOETÍ he was suspected of being in collusion with elements believed to be Soviet agents, reasons for which he was arrested together with the two officers of the CIC (LAUDER and CANCER). HASS affirms. (See Attachment 3) This, 9. But General HOTTL's relations with the Soviet Colonel STER constitute another circumstance which increased the doubts which arose regarding him and which must always be considered in the event that he should succeed, in spite of everything, in obtaining a position in the German service. 10. as is pointed out in Attachment b, Colone) HEIH2's representative arrived in Rome on the 14th of this month to make contact with MASS and, probably, with functionaries of the Minister of the I terior (BARLETTA, CAPUTO) with whom there appears to exist a basis for semi-official collaboration. 11. On the strength of this information, it is possible to rake the following deductions: a. The reorganization of the German Service is effectively under way not only in Bonn, but also abroad; b. HASS, who in agreement with the K.I. works also under the name of Podolfo (or even Carlo) OIUSTINI, is the person intended for work in Italy under connercial cover: c. It is now possible to clarify I previous report which referred to the contents of a letter from Lois 3058 in which explosives were mentioned: Lois KDER proposed to MASS a conserval sollaboration for the sale of explo-Sives in Italy and elsewhere, with on ex-official of the German political service, whose address is: Firmy August Raichberger, Beethovenstrasse h, Linz/Donzu. Source is not yet sure if the name of the person corresponds, as is likely, with that of the firm indicated above. Source states, and this is the more important point on the basis of doclarations by HASS himself, that the above firs collaborates very actively with some Soviet commands in Austria under the plan of economic substage in the Western Zone of Austria. To this and other similar firms the Sovicts sell, at favorable prices, large quantities of general food products which are then resold under cost in the Hestern Zone of Austria, thereby making normal prices fall. It has been possible in the past for Source to ascertain personally that this singular form of economic collaboration was related to a more important intelligence collaboration. Under this aspect, considering the official position of EDER, "responsible" of the German Service in Austrie, EDER-RAICHSERGER and MATCHESROBR-HASS contacts appear strange unless one wiches to presume a penetration attenut by the Jerman service into some Soviet circles.

2. Source was able to view some passages of a letter of bld from the RAICHBERGER to the HERENE firm. In this it way stated that THT, of the 80 30 type, was not available and offered instead "Donarite" in its various types. HASS explained to Source that the "Donarite" is of Soviet origin or, at least, manufactured in the Soviet Zone of Austria. A specialist in explosives could nestly determine its origin.

3. Source was able to see and study the technical description of the explosives offered: "Donarite I", Donarite 2", and gelatime "Donarite I" was offered. Subject was particularly surprised that the description dwalled more on the methods of use, on ways to blow up railroads, tridges, concrete constructions, etc., how to prepare charges and primers for various types of strongholds and terrain, than on the technical characteristics. In conclusion, the language was more military than technical. This is one possibly to the particular mentality of the manufacturer (the instructions were written directly by the factory and not by the intermediary firm).

h. HASS proposed to negotiate for the sale of this material with STACCHINI, who sells and exports similar material, especially to the Middle East.

## The Sorman Information Service

1. Forwarded in condensed form is further information picked up from MACS recently regarding the German Service which is in process of reconstitution.

2. In the summer of last year, there were already vory clearly outlined two groups of appirants for the constitution of the new German Information Service. One group was handed by Colonel HENZ, candidate of BLANK and functionary of the Security Service of the German Federal Republic; another group had as its chief the ex-Abwin General YON OVILLY, agent of the American Intelligence Service, who was the candidate numbered by that Service. A

3. In Austria at that time, the cadros of ELHZ's group were constituted as follows:

4. Shortly after the constitution of this cadre, HETL consigned to the courier VON ALBERT a scaled letter for BLARK. VON ALBERT, to whom it sopered not entirely correct for HETTL to deal directly with BLARK, inassuch as HETTL's direct superior was HETHZ, opened the letter which contained disparaging statements against HETHZ and EDER, who, when they learned of the letter's contents, obtained the removal of HETTL. (There are traces of this correspondence in the hands of the Italian authorities.) Baron MAST also withdrew from the HETHZ group (in this circumstance a trip to Rome by MAST's secretary did not take place). Immediately, HETTL and Baron MAST agreed to work in Austria with the CURLEN group. From this moment a struggle ensued in Austria between the representatives of the two groups, HETTL's group supported by the American Service which wanted to keep the new Gensen Service under control.

5. The events of the past days (HJTTL's arrest) were allegedly the result of this struggle. The requisition of the periodical edited by <u>EDER was due to</u> the pressure of the Austrian Service on the Austrian authorities, with a view to placing EDER's position in Austria in a critical light.

6. In rateliation, EDER and his friends in the HEINZ group allegedly furnished the American Service, which was already in possession of fragmantary information, definite proof of the collaboration of HOTTL with the Soviets, proof that led to his arrest. It seems that, in retrospect, the position of



Saron MAST also is critical. (In the case of  $2Dz^{p}$ , for example, part of the correspondence with MASS was intercented; not, however, the intelligence reports which MASS received at another address, probably Salaburg, care of MON ALBERT.)

7. That is HISS' position in this? He has continued to remain with the "EINZ group which appears to him to be the stronger. He mas tried, up to the present, to maintain good relations with WITL in the event that the OUZIEN group gained the upper hand. This, at least, is his version which, in consideration of past events, should be taken with some reserve.

3. The reasons for the presumed ascendency of the "EINZ group lie essentially in the fact that HEINZ already has a strong official position in John and in the fact that it is not possible that Bonn, according to HASS, could accept UURIEN, a well-known American agent, who has the minor merit of being anti-Neri, as compared to "EINZ, who was one of the top sen in the CANATIS conspiracy.

## The Jerman Intelligence Service

1. The former General of the Sicharheinstdienst, Willi HUTTL (author of the book "The Har of the Spies" which he wrote under the Decedonym HADEN) was recently arrested by the CHE on the charge of military espionage in favor of the Soviet Union.

2. The arrest, according to correspondence received by HASS at Salzburg, is intimately connected with the arrest of the imprican GIC Officers LiUBER and PUNE?, presured Soviet agents and accomplices of HOTTL. On the occasion of HOTTL's arrest, HASS' correspondence was also impounded and the latter is prooccupied by this notwithstanding his efforts to minimize the event.

J. In the past HASS, in the period in which he lived in useria, took upon himself to warn HOTTL that their contacts with Soviet Colonel STERN in Vienna had been discovered. According to HASS, "KTTL's version was completely satisfactorys

"Golonel STERN is a student at the University of Leaingrad; 't is of little importance that he was revealed to be a friend of ABGUNNV, Chief of the Soviet Security Service, recently removed. In the role of obtained he was sent to Vienna to locate, and eventually photograph, cultural material in the libraries of Vienna and other similar institutes. This work was obstructed by the fact that nearly all the technicians of libraries and cultural institutes had been purged because they were Nazis. STERN then assembled in Vienna some of these technicians, eaong when was HOTTL who in the past had been a teacher of philosophy and his.ory at the University of Vienna. He accepted and went to Vienna many times to see STERN, no harm being dore in this as it was merely a cultural thing. Unfortunately, he forget to communicate these contexts to the American

Activity of Lois EDER, Nember of the Lorman Intelligence Service

J. Source saw MASS on 14 April 1953 at 1730 hours in the Rosati bar on Piazza del Popolo.

2. Lois PDSR, "EHRI's trusted element in Austria, had arrived in Rome Saturday afternoon (11 April), later than expected because he had been called to report to the Chief for South Germany at Eunich.

3. Lois EDER is a former official of the SD who resides at Linz and at Salzburg.

b. During the conversation Source learned that HOTTL, who isd been arrested by OIC, had been subsequently freed and that he imit written to HASS telling his about his misfortune.

5. HASS' in presenting this person to Source, said that he (BDEA) would be willing to work for the Agency, <sup>32</sup> as he had vast possibilities in Austria where it is possible to get information regarding the location of all the Pussian units in the Zone, order of battle, etc. Source let him talk on in this regard, then declined the offer on the grounds that it was not of interest to him because he was a journalist.
