- 5. IN THE 1950'S GENOUD WAS CONNECTED WITH THE ALGERIAN LIBERATION MOVEMENT AND WAS A CLOSE FRIEND OF MUHAMMAD ((KHIDIR)). AN ALGERIAN POLITICIAN. **HO FLED ALGERIA WITH A LARGE SUM OF ALGERIAN GOVERNMENT MONEY. IN 1964, GENOUD WAS SUSPECTED OF HAVING AIDED KHIDIR IN THE ILLEGAL TRANSFER OF FUNDS. WAS PUT IN AN ALGERIAN JAIL FOR SEVERAL MONTHS. AND FINALLY DEPORTED.
- 6. GENOUD HAS BEEN INVOLVED WITH ARAB EXTREMISTS AND ACTIVE IN PRO-ARAB CIPCLES IN SWITZERLAND. IN 1970 HE REPORTEDLY ATTENDED THE TRIAL OF THREE TERRORISTS WHO ATTACKED AN EL-AL AIRPLANE IN ZURICH. AS AN OFFICIAL SUPPORTER OF THE PFLP, HE ACTED AS COUNSELOR BETWEEN THE ARAB LAWYERS AND THE PALESTINIAN PRISONERS. IN 1974 GENOUD CLAIMED TO BE IN DIRECT CONTACT WITH GEORGE HABBASH, SECRETARY-GENERAL OF THE PFLP, IN LEBANON.
- 7. IN 1975 GENOUD WAS ADMINISTRATOR OF THE ARAB COMMERCIAL BANK IN GENEVA AND SECRETARY GENERAL OF THE INTERNATIONAL ASSOCIATION OF FRIENDS OF THE ARAB WORLD. HE ALLEGEDLY MAINTAINED CONTACT WITH THEN LIBYAN REVOLUTIONARY COMMAND COUNCIL MEMBER. FOREIGN MINISTER AND GENERAL INTELLISENCE CHIEF, MAJOR ABD AL-MUNIM AL ((HUYI)). VIA A SPECIAL CONTACT IN PARIS. HE WAS REPORTEDLY ASSIGNED A SPECIAL MISSION BY THE LIBYANS TO CONTACT AND ASSESS UNNAMED REVOLUTIONARY GROUPS IN VENEZUELA IN MARCH 1975. THAT SAME MONTH, THE U.S. EMBASSY IN BOGOTA DENIED GENOUD'S REQUEST TO TRANSIT THE U.S. ON THE RETURN LEG OF A MBUSINESS TRIPM FROM LATIN AMERICA TO EUROPE.
- 8. IN 1975 GENOUD ALSO REGISTERED A HOLDING COMPANY, VALCOMAR, S.A., IN SKITZERLAND. THE COMPANY WAS REPORTEDLY CAPITALIZED BY THE LIBYAN GOVERNMENT AND SERVED AS A COMMERCIAL FRONT AND FUNDING CHANNEL FOR LIBYAN POLITICAL INVESTMENTS. ACCORDING TO "SCHWEIZARISCHES RAGIONENBUCH 1981", VALCOMAR IS CURRENTLY LOCATED IN FRIBOURG AT RUE, DE ROMONT 29, APPARENTLY AT THE RESIDENCE OF A G. ((CHASSOT)), ONE OF THE ORIGINAL SHAREHOLDERS. IN 1975 CHASSOT WAS DESCRIBED AS A BUSINESSMAN AND HONDRARY CONSUL FOR THE REPUBLIC OF SENEGAL AS WELL AS A RIGHT-WING TYPE WHO HAD RESIDED IN LAUSANNE FOR MANY YEARS.
