1. [] REPORT THAT A SENSITIVE SOURCE HAS REPORTED THAT SUBJECT WAS IN CONTACT WITH FRANCOIS GEORGES ALBERT ((GENOUD)) BETWEEN 8 AND 10 JUNE 1986 IN GENEVA. SUBJECT, WHO NORMALLY LIVES IN DAMASCUS CAN ALSO BE REACHED AT TELEPHONE NUMBER 11 8025 IN BEIRUT. SUBJECT AND GENOUD INTEND TO MEET NEXT EITHER IN LEBANON OR SYRIA AND THEY PROPOSE TO INVITE THE FRENCH LAWYER JACQUES ((VERGES)). [] HAS A CARD ON ONE CHEIKH EL ARD ((FAISSAL)) BORN 10 JULY 1917 OR 26 JULY 1919, A DOCTOR WHO WAS ATTEMPTING TO GAIN EMPLOYMENT WITH WORLD HEALTH ORGANIZATION (W.H.O) IN 1951. BASE HAS NO TRACES ON FAISSAL. [] WOULD APPRECIATE PREADY TRACES.

2. [] TRACES ON FRANCOIS GEORGES ALBERT ((GENOUD)), DOB: 26 OCTOBER 1915, A LAWYER, SWISS CITIZEN; HE HAS A LONG RECORD OF ANTI-ISRAELI ACTIVITIES. IN 1965 OUR RECORDS SHOW HE WAS ADMINSTRATOR OF THE BANCA COMMERCIAL ARABE IN GENEVA.

3. [] RECORDS ON JACQUES ((VERGES)), DOB: 1925, FRENCH CITIZEN, A LAWYER, A WELL-KNOW EXTREME LEFTIST, WHO DEFENDED TWO TERRORIST, BRUNO ((BREQUET)) AND MAGDALENA ((KOPP)), WHO ARE KNOWN CONTACTS OF CARLOS []
