2. HQS RECORDS INDICATE LITTLE NEW INFORMATION ON FRANCOIS GENOUD. TRACES PROVIDED IN OCTORFP 26 'MDICATE FRANCOIS GEORGE ALBERT ((GENOUD)), SUBJECT OF ______, IS A SHADY LAWYER, BUSINESSMAN, AND PUBLISHER, BORN 25 OCTOBER 1915, IN LAUSANNE, SWITZERLAND. HE HAS A LONG HISTORY OF RIGHTWING, NEO-NAZI, AND PRO-ARAB ACTIVITIES IN THE 1960'S AND 1970'S. HE HAS BEEN AN ADMINISTRATOR OF THE BANQUE COMMERCIAL ARABE OF GENEVA, AND HAS BEEN INVOLVED IN NUMEROUS OTHER BUSINESS DEALS WITH ARAB COUNTRIES. HE HELPED FINANCE ADOLPH EICHMANN'S DEFENSE AND HEADED THE INTERNATIONAL ASSOCIATION OF FRIENDS OF THE ARAB WORLD. (HE REPORTEDLY LIVED IN ALGIERS IN THE FARLY 1960S.) HE ALSO PROVIDED LEGAL AND FINANCIAL SUPPORT FOR TERRORIST FIGURES SUCH AS BRUND ((BREGUET)), AND HE ASSISTED IN 1969 IN THE LEGAL DEFENSE OF THREE PALESTINIANS WHO HAD ATTACKED AN EL AL JET IN ZURICH. HE DOES NOT APPEAR TO HAVE BEEN AS ACTIVE IN RECENT YEARS, ALTHOUGH THERE HAVE BEEN SEVERAL PRESS ACCOUNTS OF HIS TIES TO TERRORISTS AND NAZIS. GENOUD HAS DENIED MOST OF THE ALLEGATIONS AND USUALLY SUED FOR KLAUS BARBIE. AN UNTESTED SOURCE REPORTED IN NOVEMBER 1986 THAT GENOUD HAD MET WITH LARF TERRORIST GEORGES IBRAHIM ABDALLAH IN SEPTEMBER 1984. (GENOUD IS A CLOSE ASSOCIATE OF JACQUES VERGES, A DEFENSE LAWYER FOR ABDALLAH, AS WELL AS OTHER TERRORIST FIGURES SUCH AS BREGUET AND MAGDALENA KOPP, WIFF OF WELL-KNOWN TERRORIST CARLOS." BOTH KOPP AND "CARLOS." ARE CURRENTLY IN DAMASCUS.

ACCORDING TO INFORMATION FROM JWRAVEN, GENOUD WAS TO HAVE TRAVELLED TO DAMASCUS IN FEBRUARY 1987, POSSIBLY TO MEET WITH BRUND BREGUET, A CLOSE ASSOCIATE OF "CYCALOS." HOS RECORDS DO NOT INDICATE CONFIRMATION OF THE TRIP OR MEETING. WE HAVE NO RECORD OF HIS ACTIVITY AFTER THIS TIME.
