TEXT:

1. [] MET WITH [] IN BERN HOTEL ROOM ON 06 SEPTEMBER. [] SAW FRANCOIS ((GENOUD)) IN LAUSANNE LATE AFTERNOON 05 SEPTEMBER AFTER FIRST MEETING WITH []. GENOUD HAD NO FURTHER INFORMATION ON CARLOS ORGANIZATION MOVEMENT PLANS. [] WAS SCHEDULED TO MEET WITH GENOUD A SECOND TIME LATE AFTERNOON 06 SEPTEMBER.

2. [] GAVE [] VOICE CODE BEING HELD HQS FOR USE ON [] LINE SHOULD [] LEARN OF ANY DEFINITIVE PLANS TO MOVE BY MEMBERS OF THE GROUP. GENOUD BELIEVES THAT MAGDALENA ((KOPP)) AND CHILD CAN MOVE TO GERMANY AS SHE HAS VALID GERMAN PASSPORT. [] KNOWS OF NO OUTSTANDING WARRANTS FOR MAGDALENA. GENOUD SURMISES FROM VISIT TO DAMASCUS THAT CARLOS IS SEEKING TEMPORARY SANCTUARY IN CUBA, BUT THAT ENTIRE GROUP ALSO EXPLORING WHETHER MOVEMENT TO YEMEN IS VIABLE OPTION. ALI ((ISAWI)) MAY REMAIN WITH GROUP OR JOIN WITH UNNAMED PALESTINIAN ORGANIZATION OUTSIDE SYRIA.

3. RELOCATING JOHANNES ((WEINRICH)) REMAINS A PROBLEM BECAUSE OF GERMAN GOVERNMENT INTEREST AND OUTSTANDING WARRANTS. CARLOS HAS SENT SUMMONS TO [] TO COME TO DAMASCUS TO DISCUSS THE WEINRICH MOVEMENT. ALTHOUGH BEING PRESSURED BY GENOUD, [] THUS FAR HAS DECLINED A VISIT TO DAMASCUS. HOWEVER, [] IS WILLING TO HELP FROM EUROPE AND HAS CONVEYED THIS MESSAGE TO CARLOS. [] UNDERSTANDS THAT CARLOS WANTS [] TO GO TO LIBYA TO PERSONALLY APPEAL FOR LIBYAN SANCTUARY FOR WEINRICH. CARLOS ALSO DESIRES THAT [] SERVE AS COMMUNICATION LINK BETWEEN VARIOUS ORGANIZATION MEMBERS SHOULD THE ORGANIZATION SPLIT AS A RESULT OF MOVEMENT.

4. [] HAS SCHEDULED [] CONTACT MORNING 13 SEPTEMBER. [] PLANS MEET WITH [] IN WESTERN AUSTRIA ON 20-21 SEPTEMBER SUBJECT SEPARATE CABLE SHOULD [] PASS DEFINITE MOVEMENT PLAN AT 20 SEPTEMBER MEETING. [] WILL CONTACT [] FOR CABLE TRANSMITTAL. [] HAS [] CONTACT INSTRUCTIONS.
