TEXT:

1. ACTION REQUESTED: COMMENTS/INFO PER PARA 5 AND 6.

2. (C/O) HELD LENGTHY, FRANK DISCUSSION ON WITH ON 8 NOVEMBER. WAS PRESENT AND TOOK NOTES WHICH PREPARED FOR SEPARATELY, I.E. NOT WITH NORMAL LIAISON REPORT WHICH RECEIVES WIDER DISTRIBUTION. ON 11 NOV CALLED FOR MEETING - SEE PARA 5.

3. C/O STAYED WITH AREAS AGREED UPON IN REFS -- PER REF B NO DETAILS OF GREEK OPERATION SOLELY FACT WE HAD HIM STAY IN TOUCH WITH GREEK CONTACTS AND THAT HE HAD VISITED GREECE. ALSO, NO MENTION OF OUR PUSHING CHRISTA ((FROEHLICH)) CONTACT. PLEASE NOTE THOUGH THAT MENTIONED FROEHLICH AND AGAIN SAID SHOULD BE ABLE TO PROVIDE SOME INFORMATION ON HER, HER WHEREABOUTS AND PAST AND PRESENT ACTIVITIES.

4. RE INVOLVEMENT IN TERRORIST ASSASSINATION: SAID (AND AMPLIFIED DURING 11 NOV MEETING) THAT REPORT INDICATED PFLP TARGETTING OP, WITH ACTIVITY IN EUROPE AND A POSSIBLE HUNGARIAN CONNECTION. HE DID NOT IDENTIFY SERVICE WHICH PROVIDED INFORMATION, BUT SAID IT WAS RECEIVED AROUND THE SAME TIME AND WITH REFERENCE TO SECURITY MEASURES REQUIRED FOR MIDDLE EAST PEACE CONFERENCE (WHICH HELD IN MADRID). THIS LEADS US TO SURMISE THAT ISRAELIS ARE THE ONES WHO PASSED THE INFO. AND BOTH SAID THERE WAS NO/NO FRENCH CONNECTION.

5. IDENTIFICATION OF POSSIBLE TARGET: BASED ON INFO FROM C/O RE CARLOS OVERTURE TO AND DESIRE TO HAVE HIM ENGAGE IN PLANNING ASSASSINATION, CALLED FOR MEETING ON 11 NOV AND SAID THEIR INFO INDICATED MOST LIKELY TARGET WAS GEORGES EDGARD ((TOUTOUNJI)), BORN 9 OCT 58, "CLOSE RELATIVE OF WIFE OF BECHIR GEMAYEL" AND FORMER REPRESENTATIVE OF FORCES ARMEES LIBANAISES IN PARIS. CONTINUED THAT THEY WOULD TAKE SITUATION SERIOUSLY AND ASSUMED WE WOULD MAKE (HAD MADE) THE NECESSARY ALERTS/WARNINGS. THIS IS OF COURSE SAME CONCLUSION HQS HAD REACHED IN MAY/JUNE. ASSUME THAT ALL NECESSARY STEPS TAKEN AT THAT TIME, EVEN THOUGH DECLINED TO BECOME INVOLVED.

6. INFO ABOUT POSSIBLE HUNGARIAN ANGLE REMINDS US OF OCCURRENCE EARLIER THIS YEAR, WHEN SWISS LICENCE PLATE STOLEN IN ZURICH TURNED UP IN HUNGARY IN CONNECTION WITH OP. HQS ALL PROMISED FOLLOW-UP FOR REGARDING LICENSE PLATE, BUT NO INFO HAS BEEN FORTHCOMING. PLEASE CHECK IF THERE IS A POSSIBLE CONNECTION. ALSO, IF WE CAN GIVE THE

PROMISED FOLLOW-UP (THIS WAS CASE WHERE THEY REACTED VERY QUICKLY ON A WEEKEND AFTERNOON).

7. RE IDENTIFYING MAHMOUD AND MOHAMMAD: [] IS LOOKING INTO WAYS OF IDENTIFYING BOTH MAHMOUD AND MOHAMMAD. HE WILL GET BACK TO US. HE KNOWS THEY USED TRUE-NAME AUSTRALIAN DOCUMENTATION, THAT WE DO NOT KNOW TRUENAMES, THAT THEY MAY HAVE USED EITHER AIRPORT (ZURICH OR GENEVA), THAT THEY MAKE CONTACT THROUGH FRANCOIS ((GENOUD)). AND THAT THEY DO NOT NECESSARILY OVERNIGHT IN LAUSANNE. ZURICH HOTEL RECORDS ARE VERY GOOD, BUT MUST BE SEARCHED BY HAND. SOME AREAS ARE COMPUTERIZED. [] WAS HOPEFUL THAT THEY COULD BE TRACKED.

8. RE GENOUD: [] SAID THEY HAD INVESTIGATION RUNNING ON GENOUD, PHONE TAPS AND "OTHER METHODS" (WHICH ON THE BORDERLINE OF LEGALITY, ESPECIALLY IN CURRENT CLIMATE), AND HAD NEVER BEEN ABLE TO OBTAIN ANY EVIDENCE OR INFORMATION TO TIE HIM INTO TERRORISM. HE KNOWS THE PLAYERS, HAS BEEN INVOLVED ON EITHER END OF THE SPECTRUM, BUT EVIDENTLY HAS BROKEN NO SWISS LAW. [] WILL LOOK INTO WHAT CAN BE DONE WITH REGARD TO GENOUD.

9. [] HAD NO PROBLEM WITH CONTINUING AS BEFORE. C/O DID NOT/NOT INFORM HIM THAT WE IN [] (I.F.C.) WOULD BE GETTING DIRECTLY INVOLVED. [] DOES NOT INTEND TO CONTACT [] IN THE IMMEDIATE FUTURE NOW., PROBABLY NOT UNTIL EARLY NEXT YEAR. HE WILL LET US KNOW, IF NOT BEFORE THEN IMMEDIATELY AFTER. HE SAID IT WOULD BE USEFUL TO SEE HOW [] REACTS, IF HE REVEAL CONTACT WITH PNINFINITE, AND IF HE REPORTS BACK [] TO US. IT GOES WITHOUT SAYING THAT [] WILL NOT REVEAL TO [] THAT HE IS AWARE OF PNINFINITE CONTACT.
