1. This refers to earlier reports on Goleniewski's allegations which appeared in print in the HERALD OF FREEDOM and was reprinted by AMERICAN MERCURY MAGAZINE.

2. [Redacted] now in Washington, was interviewed by Representative Ashbrook at his offices on the Hill 10 July regarding the Goleniewski allegations. [Redacted] went over on request and was shown the Goleniewski publication and asked for his evaluation of the information. [Redacted] is stated to have said that he thought Goleniewski's statements were bizarre, that he was obviously unbalanced and that his publication should be disregarded. Assertedly, Ashbrook is considering taking public testimony on the Goleniewski allegations.
