1. Direkte Funkverbindung
2. Austausch von Geheimschrift-Verfahren
3. Kennzeichnung des Siegels
4. Überwachung des Funkverkehrs Polen - CSR

In Weiterführung unserer begonnenen Zusammenarbeit überreiche ich Ihnen mit Kurier im Auftrag des Obersten Heinz;

1. Eine Übersicht über die sowj. Landstreitkräfte in der SBZ.
2. Eine Gliederung des Ministeriums des Inneren der SBZ.
(Beide Berichte sind in einem grünen Heftor zusammengefasst)
3. Eine Ausarbeitung über die Aluminium-Industrie Ungarns.

Den weiteren ist eine Original-Meldung in Abschrift beigelegt, die sich mit den Flotten-Manövern der rumänischen Donau-Flottille befasst. Wir wären Ihnen dankbar, wenn Sie uns anlässlich des nächsten Austausches, der vorbehaltlich Ihres Einverständnisses, voraussichtlich gegen Mitte Oktober geplant ist, eine Auskunft darüber erteilen könnten, ob Sie Informationen ähnlicher Art erhalten haben.

Translation of letter from the German:

24 September 1953

Personal to Colonel ROSSI, Rome, Italy.

Very honored sir:

My superior, Colonel HEINZ, has been constantly ~~occupied~~^{preoccupied w/} through the important governmental talks in connection with the recent(German) elections. He was therefore not in the position to write to you ~~concerning~~ taking a position on the suggested points for improvement of collaboration between us. He wants me to greet you warmly and requests your understanding that up to the present he has given no firm opinions concerning the following points:

1. Direct radio contact;
2. Exchange of S/W methods;
3. Recognition of seals;
4. Monitoring of Polish-Czech Radio Traffic.

Extending our already commenced collaboration, I transmit herewith by courier on orders of Colonel HEINZ the following:

1. Survey of the Soviet ground forces in the SovOccupation Zone(Germany?)
2. OB Run-down on the Ministry of Interior of East Germany.(Both reports are attached together in a green cover).
3. A survey of the Hungarian Aluminum Industry.

Further is ^{copy of an} ~~an original~~ report attached, concerning the fleet maneuvers of the Rumanian Danube River flotilla. We would be very grateful if, ~~in~~ ^{as regards} ~~the~~ of our next exchanges probably to take place in mid-October if you are in agreement, you could impart to us any info concerning it(i.e. the above

report on Danube fleet) if you receive any information of a similar nature. Further, we would be very grateful if you could pass to us a survey report on the Bulgarian armed forces(Army, Navy, Air Force, and Border Guard units) and on the Soviet occupation troops in Bulgaria.

We are sending the above-referred to attachments to you in double envelopes on which both wrappings have been sealed five times.
