3. IDEN 2 WROTE [ ] AGAIN 11 OCT 66 QUOTING  
FOLLOWING ANSWER RECEIVED BY HIM FROM IDEN 4: "I CANNOT  
RECALL OF HAVING HEARD OF IDEN 1. TWO OF MY FORMER CO-  
WORKERS, WHOM I CONTACTED OVER TELEPHONE HAVE ALSO NO  
RECOLLECTION OF HIM. THIS DOES NOT MEAN THAT HE DID  
NOT BELONG TO MY ORGANIZATION. IT IS DIFFICULT TO  
REMEMBER THINGS AFTER SO LONG TIME. IF HE DID, HE  
MUST HAVE PLAYED A VERY SUBORDINATE ROLE." IDEN 2
