1. WHILE SMABOVE, PER PARA 2, REF A, INDICATES NO INFO THAT SIIMER VISITED TORONTO AREA, LNERGO INFO REFLECTS HE ADMITTED AT NIAGARA FALLS, NEW YORK, 15 SEPTEMBER 1965 AND DEPARTED U. S. FOR LONDON 23 SEPTEMBER. PASS ABOVE TO SMABOVE AND REQUEST THEY RE-CHECK THEIR RECORDS.

2. FYI: ONE OF SIIMER'S CONTACTS IN U. S. AND WITH WHOM SIIMER IN TELEPHONE CONTACT IN SEPTEMBER 1965, IS EMPLOYED FOREIGN DEPARTMENT, SOUTH AMERICAN BRANCH, OF LARGE COMMERCIAL BANK IN NEW YORK CITY. HE REPORTED TO HAVE MADE BUSINESS TRIP TO SOUTH AMERICA IN 1966. WHILE TRIP COULD HAVE BEEN FOR LEGITIMATE BUSINESS REASONS, HE IS CONCEIVABLY A LEAD TO EERIK HEINE INCOME SOURCES IN WHICH HEADQUARTERS ESPECIALLY INTERESTED, PER REF B, PARA 4.
