AND CHOSE TO JOIN THE SS. HE STATED THAT THE WAFFEN SS WAS THE ONLY MILITARY UNIT OPERATING LOCALLY, AND THAT HE WAS EAGER TO JOIN IT AS AN ELITE UNIT. DIRECTLY AFTER BEING DRAFTED, SUBJECT WENT TO HAMBURG. WHERE HE SERVED AS "ENTFERNUNGSMESSER" (DISTANCE MEASURER) IN THE "STANDARTE GER-MANIA", AN ANTIAIRCRAFT (FLAK) UNIT, UNTIL 1940. DURING THIS TIME, HE WAS PROMOTED TO "UNTERSTURMFUEHRER" (EOUIVALENT OF SUB-LT).

AFTER FURTHER ANTIAIRCRAFT TRAINING AT BAD TOELZ AND THE NAVAL SCHOOL AT MOERITZ-WARNEMUENDE, HE SERVED WITH LEIBSTANDARTE ADOLF HITLER, IN RUSSIA FROM 1940 TO 1942.

IN OCTOBER 1942, SUBJECT WAS FURLOUGHED FROM THE SS
TO ATTEND MEDICAL SCHOOL. HE ATTENDED THE UNIVERSITY
OF PRAGUE UNTIL JUNE 1943, THEN TRANSFERRED TO THE
UNIVERSITY OF GIESSEN. DURING THIS TIME, HE WAS A
RESERVE ANTIAIRCRAFT OFFICER OF THE WAFFEN SS.
5. SUBJECT COMPLETED HIS MEDICAL STUDIES IN 1950, AND
SINCE THEN HAS SERVED AS A DOCTOR IN MAINZ, AND CHIEF
PHYSICIAN IN ELTVILLE. HE STATES THAT HIS
INVOLVEMENT IN THE SS WAS PURELY MILITARY, NOT
IDEOLOGICAL, AND THAT HE NEVER PARTICIPATED IN OR ORDERED
ANY ACTIVITIES WHICH WOULD RENDER HIM
INELIGIBLE UNDER SECTION (33). HE PRESENTED A DOCUMENT
SHOWING THAT THE RHINELAND-PALATINATE GOVERNMENT HAD
FOUND HIM CLEAR OF ANY WRONG DOING IN 1949, AS PART
OF HIS MEDICAL CERTIFICATION.
