2. STEIN JOINED THE NSDAP ON MAY 1, 1933, MEMBERSHIP NUMBER 3168602 AND WAS A MEMBER OF THE STURMABTEILUNG (SA) FROM MAY 1, 1933 TO APRIL 1, 1934. HE JOINED THE GENERAL SS ON APRIL 1, 1934, SS MEMBERSHIP NUMBER 259821. THERE IS NO MENTION OF ANY GENERAL SS ASSIGNMENTS.

3. HE SERVED WITH THE WAFFEN SS EFFECTIVE SEPTEMBER 1939 AND ATTAINED THE GRADE OF CAPTAIN. HE SERVED WITH THE LEIBSTANDARTE SS ADOLF HITLER, FROM SEPTEMBER 1939 AND DETAILED TO THE REICHSGESUNDHEITSFUEHRER (REICH MEDICAL

DEPARTMENT); SANITAETS INSPEKTION DER WAFFEN-SS (MEDICAL INSPECTORATE), 1940; SS FUEHRUNGSHAUPTAMT/SANITAETSWESSEN DER WAFFEN SS/AMTSGRUPPE "D" (SS OPERATIONAL MAIN OFFICE/ MEDICAL BRANCH OF THE WAFFEN SS/SECTION D), 1944; DETAILED TO THE REICHSGESUNDHEITSFUEHRER UND REICHSFUEHRER SS/REICHSKOMMISSAR FUER DIE FESTIGUNG DEUTSCHEN VOLKSTUMS (LEADER OF THE REICH MEDICAL DEPARTMENT AND REICH LEADER OF THE SS/COMMISSIONER FOR THE PRESERVATION OF GERMAN NATIONALITY), IN 1944.

4. STEIN STUDIED MEDICINE AT THE UNIVERSITIES OF GOETTINGEN, FREIBURG/BREISGAU AND BERLIN DURING THE PERIOD 1932 TO 1938 AND PASSED HIS MEDICAL STATE EXAM ON DECEMBER 16, 1938. HE WAS THEN EMPLOYED BY THE WESTEND KRANKENHAUS, BERLIN. AS OF AUGUST 23, 1940, HE WAS WORKING AS VERBINDUNGSARZT (LIAISON) BETWEEN THE VOLKS-DEUTSCHE MITTELSTELLE (RACIAL GERMAN ARBITRATION OFFICE) AND THE REICHAERZTEKAMMER (MEDICAL ASSOCIATION) AND FROM MAY 1941 ON FUNCTIONED AS AN UMSIEDLUNGSREFERENT UND PERSONALREFERENT (SPECIALIST IN RESETTLEMENT AND PERSONNEL QUESTIONS). ACCORDING TO HIS OWN STATEMENT OF 1944, HE TOOK PART IN ALL RESETTLEMENT TRANSACTIONS IN HIS CAPACITY AS A PHYSICIAN.

5. HE WAS INITIALLY REGISTERED WITH THE BEZIRKSVEREINIGUNG (LOCAL GROUP) BERLIN OF THE AERZTEKAMMER; THEN WITH THE BEZIRKSVEREINIGUNG STETTIN, FROM APRIL TO AUGUST 1940 AND EVENTUALLY WITH THE BEZIRKSVEREINIGUNG BERLIN FROM AUGUST 23, 1940. HE WAS ADMITTED TO MEDICAL PRACTICE ON OCTOBER 1, 1939. HE WAS AWARDED THE KRIEGSVERRDIENST KREUZ 2. KLASSE MIT SCHWERTERN (WAR MERIT CROSS, 2D CLASS WITH SWORDS) AND THE VOLKSPFLEGEHRENSZEICHEN 3. STUFE (BADGE OF HONOR FOR CARE AND PRESERVATION OF GERMAN NATIONALITY, 3D CLASS), DATE NOT GIVEN. NO FURTHER INFORMATION IS AVAILABLE. KORNBLUM
