DAHLMANN HAS PROVIDED ADDITIONAL INFORMATION ON HIS WARTIME SERVICE IN THE WAFFEN SS. DAHLMANN STATED THAT DURING HIS INCARCERATION BY THE SOVIETS BETWEEN 1948 AND 1954 HE WAS INTERVIEWED IN DETAIL ABOUT HIS ACTIVITIES IN THE BALKANS. THE CONCLUSION, ACCORDING TO DAHLMANN WAS THAT NEITHER HE NOR HIS UNITS WERE INVOLVED IN WAR CRIMES.
