1. BDC SUMMARY AND MR. CROST'S TESTIMONY DIFFER IN SEVERAL RESPECTS. ACCORDING TO SUMMARY, HE WAS A TEACHER AT BOTH **ADOLF HITLER** SCHOOLS AND AT ORDENSBERGEN BETWEEN 1938 AND 1944.

2. THE **ADOLF HITLER** SCHOOLS AND THE ORDENSBERGEN WERE SPECIAL PARTY SCHOOLS SET UP TO TRAIN A NAZI IDEOLOGICAL AND RACIAL ELITE. THEY IMPARTED A DOCTRINE OF RACISM AND RAMPANT MILITARISM, AND THE TEACHERS EMPLOYED THERE WERE CHOSEN FOR THEIR COMMITMENT TO THE NAZI PARTY AND ITS DOCTRINES.

3. THE ORDENSBERGEN WERE UNDER THE CONTROL OF THE RASSE UND SIEDLUNGS HAUPTAMT AND THE SS-HAUPTAMT DURING PERIODS WHICH CORRESPOND TO MR. CROST'S ASSIGNMENTS TO THOSE ORGANIZATIONS. IF HE WERE, IN FACT, A TEACHER OR ADMINISTRATOR IN EITHER OR BOTH OF THESE TYPES OF SCHOOL, HE WOULD BEAR A STRONG PRESUMPTION OF INELIGIBILITY UNDER 212(A)(33).
