1. VISAS TWO HERMANN HEINRICH SCHMALOER (33).
2. MR. SCHMALOER JOINED THE STAHLHELM, A RIGHT-WING PARAMILITARY ORGANIZATION, AT THE AGE OF EIGHTEEN, AND THE SA SHORTLY THEREAFTER. HE WAS A MEMBER OF THE LEIBSTANDARTE SS **ADOLF HITLER** FROM AN EARLY DATE. HIS CONTENTION, THEREFORE, THAT HE WAS UNINTERESTED IN POLITICS IS INGENUOUS. HE WAS OBVIOUSLY A BELIEVER IN RIGHT-WING, AND LATER NAZI IDEOLOGY AS A YOUTH. HIS SERVICE WITH THE LEIBSTANDARTE IN THE SOVIET UNION CORRESPONDS TO THAT UNIT'S MASSACRE OF SOVIET PRISONERS OF WAR AND THE GENERAL EXTERMINATION OF CIVILIANS AT KHARKOV. AS THE HEAD OF A SIGNALS UNIT, IT IS REASONABLE TO BELIEVE THAT MR. SCHMALOER ASSISTED IN THE COORDINATION OF THESE ATROCITIES.
3. HIS SERVICE WITH HIMMLER'S FIELD COMMAND POST IN RASTENBURG ALSO PUTS HIM SQUARELY WITHIN THE PURVIEW OF 33. HE WOULD UNDOUBTEDLY HAVE ASSISTED IN THE

TRANSMITTING OF ORDERS TO CONCENTRATION CAMPS, TO EINSATZGRUPPEN, AND TO THE VARIOUS SLAVE LABOR ENTERPRISES RUN BY THE SS.

4. THE INCIDENT IN 1940 FOR WHICH HE WAS ARRESTED BY THE BRITISH IS THOROUGHLY MISREPRESENTED IN HIS TESTIMONY. IN MAY OF THAT YEAR, 331 MEN OF THE 2ND ROYAL WARWICKSHIRE REGIMENT WERE TENACIOUSLY DEFENDING A SMALL TOWN CALLED WORMHOUDT, SOME TWELVE MILES FROM DUNKIRK. THEY WERE FINALLY OVERCOME BY THE LEIBSTANDARTE. SOME EIGHTY MEN WERE TAKEN PRISONER BY THE SEVENTH COMPANY OF THE LEIBSTANDARTE'S 2ND BATTALION. ANGERED BY THE TENACITY OF THE DEFENSE, SS MEN CROWDED THE PRISONERS INTO A NEARBY BARN AND MASSACRED THEM USING HAND GRENADES AND MACHINE-GUN FIRE. IT WAS THEN THAT SOME TRIED TO ESCAPE. ONLY FIFTEEN OF THE EIGHTY MEN SURVIVED. NONE OF THE PERPETRATORS WAS EVER BROUGHT TO JUSTICE.

5. BASED UPON THE COMPENDIUM OF EVIDENCE IN THIS CASE, MR. SCHMALOER MUST BE HELD TO BE INELIGIBLE UNDER 212(A) (33). HE WILL BE ENTERED INTO AVLOS AS 33. SHULTZ
