1. IN ADDITION TO THE BDC SUMMARY PREVIOUSLY FURNISHED,
FOLLOWING IS ADDITIONAL INFORMATION PERTAINING TO
MUELLER-"TEOT" 'S ASSIGNMENT TO THE SS RASSE UND SIEDLUNGS
HAUPTAMT (SS RACE AND SETTLEMENT OFFICE):

AS OF APRIL 1940 SUBJECT WORKED ON A HONORARY BASIS FOR
THE SS RACE AND SETTLEMENT OFFICE. ACCORDING TO A LETTER
OF THE CHIEF OF THE HEIRATSAMT (MARRIAGE OFFICE), OTTO
HEIDER, MUELLER-TEOT AS A SCIENTIST COULD BE EXPECTED TO
WRITE BOOKS, ESSAYS AND ARTICLES IN THE FIELD OF RACE
RELATIONS EXPOUNDING ON THE PROPER ATTITUTES WHEN CONSID-
ERING THE CHOICE OF A WIFE FOR SS MEMBERS WHO WERE BEING
CONSIDERED FOR THE RACIAL PURIFICATION TIEORIES OF THE
SS RACE AND SETTLEMENT OFFICC. IT APPEARS THAT THE REASON
WAS TO PROMOTE GOOD AND SANE GERMANIC IDEAS RELATING TO
THE SCIENTIFIC CONSIDERATION OF RACE QUESTIONS BY AUTIORS
AND FOLKLORIST. ACCORDING TO STATEMENTS BY MUELLER-TEOT
E WAS ASSIGNED BY REICHSFUEHRER SS TO WORK OUT A SPE-
