1. Reference is made to the name check request, file No. A13 002 405, dated 21 November 1962, subject as above, whose name you desired checked against the files of this office. The files contain the following information concerning Subject.

2. A report dated 6 September 1951 from a predecessor organization of the West German Intelligence Service (WGIS), indicated that Subject was dropped without prejudice as a source of intelligence information on the 31st of May 1951.

3. A report dated 19 November 1957 contained information received from a predecessor organization of the West German Intelligence Service which indicated that Subject was commissioned by the Hungarian Army in 1918 as a gendarmerie officer. During the SZALASI putsch in Hungary in October 1944, Subject received the rank of Major General of the Police. On 2 May 1945, he became a prisoner of the Americans and was held in a POW camp until June 1946.
