CALES ADMITTED THAT HOEHER AND KLING OF ABTEILUNG 5, GERMAN POLICE
(SEE ERBA 3741) END SEPT BEGINNING OCT 52 VISITED HIM SEVERAL
TIMES AT NIGHT PHOTOGRAPHED IMPORTANT SSD FILES. THIS CLEARLY
INDICATES ZIPPER PENETRATING TPEMBER BEFORE POB AWARE OF IT AND
BEFORE BOB ATTEMPTED CALES RECRUITMENT.

3. HOEHER TOLD CALES THAT HE INTERESTED IN HANSEN OF
TPEMBER WHO IS HANDLING ILLEGAL EAST WEST TRADE. CALES STATES
HE ADAMANTLY REFUSED APPROACH HANSEN. HOEHER STATES THIS ONLY
MATERIAL OF TPEMBER NOT AVAILABLE HIS ORGANIZATION, INDICATING
HIS ORGANIZATION HAS ANOTHER TPEMBER PENETRATION.
