4. POB WILL GLADLY FORWARD ANY NEW DATA THIS CASE. REQUEST
SAME SERVICE BOB, THOUGH WE RECOGNIZE LEGITIMATE SECURITY DANGER
TPEMBER CAUSED BY HOEHER DISAPPEARANCE AND AGREE ANY CALES INTERROGATION
WHICH CAN CREDIBLY BE ATTRIBUTED INVESTIGATION THIS CASE, DO NOT
BELIEVE HOEHER CASE SHOULD BE USED AS EXCUSE REOPEN QUESTION OF ZIPPER.
