4 REPORT OF FINDINGS -

AUSS BRAKEIER

On 12 October 1955, Source "A" revealed the following information economing his trip to LEIPZIG (US 1891), East Germany:

a. Upon artival at LEIFZIG, Hauptbahahof at 1730 hours, 8 October 1955, Source was met by Wolfgang HOEHER. Source was then escorted to HOEHER! spartment located at Elingenstrasse 17, where HOERER resides with his mother and fifteen year old son. At present, HORHER's son attends a Hochschule in LEIPEIC. During the course of the evening, Source had dinner with HOEHER in the spartment and HORHER talked of his experiences during Sorld Mar II. how he had been captured in 1944 by the Russians and imprisoned at LITZMANESTADY (nos), Bust Germany. HOEHER related how he had been sent to MOSCOW (nos) 855% in 1947 and for a period of two and one-half years received AFFIFA (inti Fascist) training. HOEHER related also how he had worked for CARARIS in Absorby "P" during the second World War. MOREER claimed to have been released by the Soviets in 1950 and resettled at an undesignated city in west Germany. HOEHER's wife, first name unknown, allegedly still resides in an undesignated city in West Germany with their eight year old daughter and a six weeks old son. From HONHER allegedly visited HONHER in LEIPZIO during the Christmas season of 1954, at which time she conceived the six week old son: HOEHER claimed to have never seen the son and has no intention of coming to West Germany because of the danger involved. BORRIZ related that he at one time had been a member of the GEHLES Organization in BERLIS (UU 9220), Germany, but had been out off from all information and access to domelers, therefore he had severed connections with the CRHAER Organization and had gone to East Germany, where he is now working for a "mivil absehr" (civilian nounter intelligence).

b. At approximately 2400 hours, 6 October 1955, HORHER and Source went by taxi to a bar called "Pemina", located on Stadtplats, exact number unknown, in LEIPZIG. While in the bar, HOEHER ordered several drinks and quite openly requested Source to do the following for him:

- (1) Attempt to obtain names of members of the GEHLES Organization in west Germany, as well as names of former members of the Brandsnburg Division who are now in the Amt fuer Verfassungsschuts (Office for the Protection of the Constitution), and members of the Political Section of the German Police.
- (2) HOREER requested that Source collect copies of the publications "per Spiegel" (The Mirror) and "Militaer-Politische Forum" (Military and Political Forum) and deliver names and the publications to HOEHKR on Source's next trip to the East Zone.

a. HORRER invited Source to attend a three or four day meeting (CONT.D)

of the Deutsch-Sowjetische Freundschaft Gruppe (German-Seviet Friendship Group) to be held in late November, 1955 in LEIPZIG.

d. HOKHER explained to Source that he wanted the data on the members of the GEHLEN Organization, because his office in East Germany knows that there are presently 3,800 persons in the GERLEM Organisation, that it is supported by the Americans, and that the organization is to be out in strength to approximately 2,000 persons. HORHER believes that of the 1,800 relieved from the GERLEN Organisation, some can be approached with the purpose of obtaining names of persons remaining in the employ of GRHLEH. Source told EGEEER, that because he works all day at his place of employment and most of his evenings are taken up with his political activities, he would not be able to obtain the names which HOERER requested. HOERER did not pursue this matter further. HOEHER further stated that the person responsible for the GEHLEM Organization in southern west Germany is a Fau BENZIECER. BENZIECER had worked for "Organisation JOHE" of the west German Intelligence until 1950, at which time BENZINGER started to work for GEHLEN. REMITINGER is now believed residing with the widow of a former samuill owner in EARLSHUEE, address unknown. REMAINCER is also a good friend of one Biward or Binard HILLER, STUTTCART/Maiblingon (NV 2509), Germany, Winnendersteige 17, a member of the DEP (Doutsche Reichs Partei-German Reichs Party).
