1. CIC SAYS INFO ON WOLFGANG HOEHER NOT YET PASSED DUE G-2 FAILURE THUS FAR REPLY TO CIC REQUEST FOR AUTHORITY PASS. CIC SAYS SOURCE OF INFO HAS BEEN CONSIDERED VERY SENSITIVE, AND OP INVOLVED IS ONE TIGHTLY CONTROLLED BY G-2.

2. ON 4 APRIL <sup>CLS</sup>COS\* MADE LATEST IN SERIES EFFORTS SECURE INFO. CIC, UNOFFICIALLY, NOW SAYS OP INVOLVED FIZZLING OUT AND IN CIC VIEW SOURCE NO LONGER SENSITIVE. CIC <sup>RENEWING</sup>REFUSING\* REQUEST FOR G-2 AUTHORITY PASS INFO, CITING CHANGED CIRCUMSTANCES.

3. FOR INFO KUBARK ONLY PENDING OFFICIALY PASSING, CIC SAYS INFO ON HOEHER CONSISTS FOLLOWING:

A. CIC SOURCE HAS REPORTED HOEHER AS SAYING HE NOT KIDNAPPED FEBRUARY 53 BUT WENT DDR VOLUNTARILY.

B. INTERCEPTS RUN BY CIC IN OP INVOLVING SOURCE ABOVE INFO CAUGHT LETTER FROM HOEHER TO A MUNICH ADDRESSEE NOT NAMED

BY CIC. LETTER INDICATED HOEHER ON UN-NAMED DATE PLANNED ATTEND UNSPECIFIED MEETING IN MUNICH. CIC HAS BEEN MAINTAINING "APPROPRIATE PRECAUTIONS" TO OBSERVE HOEHER IN EVENT HE SHOULD ENTER FED REP.

4. WHEN AUTHORIZED BY G-2, CIC WANTS TO PASS ABOVE INFO IN DETAIL AND DETERMINE OUR AND UPSWING'S VIEWS RE APPREHENDING HOEHER IF HE SHOULD ENTER FED REP.

5. SUGGEST <sup>VLS</sup> COS, WITHOUT REVEALING CIC HAS REVEALED NATURE INFO HOEHER, PROD G-2 BY CITING THAT, AFTER VOLUNTEERING IN DECEMBER 1955 FACT CIC HAD INFO ON HOEHER WHICH CIC WOULD PASS IF HOEHER OF INTEREST TO US OR UPSWING, CIC HAS INDICATED G-2 WITHHOLDING AUTHORITY TO PASS.

6. FOR HEID: REF B STATED HOEHER FORMER UPSWING SECTION CHIEF KIDNAPPED BERLIN FEBRUARY 1953. IN ADDITION HIS UPSWING KNOWLEDGE; HE HAD ACCESS TO UNKNOWN AMOUNT CADROT INFO.
