- 1. CERTAINLY AGREE WITH DIR THAT ODOPAL TURNOVER OFFER SHOULD BE ACCEPTED
- 2. FROM PULL POINT OF VIEW, UPSWING SECURITY FACTORS AND POSSIBILITY PENETRATING HOSTILE OPS AGAINST UPSWING REPRESENT PARAMOUNT ASPECTS OF CASE AT LEAST UNTIL THIS ANGLE COMPLETELY ANALYZED. WE THEREFORE FEEL CASE SHOULD BE ACCEPTED FOR UPSWING WITHOUT INDICATING TO ODOPAL WHAT WE INTEND TO DO WITH IT. SHOULD THIS BE TRUE, KUBARK ATTEMPT RUN CASE WITHOUT INFORMING UPSWING WOULD OBVIOUSLY RUN INTO TROUBLE.
