1. REF SUBJ WAS EMPLOYED BY [] I.S. RUNNING POSITIVE NET FROM UNKNOWN DATE TO APR 1953. RAN CE NET FOR UPSWING FROM MAY 50 TO END MAR 51 WHICH PRESUMABLY SOURCE OF DROPPED NOTICE LISTED REF. DROPPING BASED ON FRONT SOUNDING REASON GIVEN BY CASE OFFICER TO EFFECT SUBJ VIOLATED A CONFIDENCE OF CASE OFFICER. AFTER 53 DROPPED BY [] WAS PICKED UP BY ANOTHER UPSWING POSITIVE OFFICE AND RUN UNTIL AUG 53. THEN BECAME CHAIRMAN OF SPRUCHAUSSCHUSS IN BUNDESNOTAUFNAHMEVERFAHREN, SUBORDINATE TO MARTIN COSSMANN. UPSWING HAD NO RECORD HE CURRENTLY LIVING DRESDEN.

WE VERY INTERESTED NATURE ODOPAL INTEREST AND EXTENT THEIR INFO, AND IF ODOPAL WILLING, [] WOULD LIKE TO DISCUSS WHILE IN STUT 25 FEB 57.
