1. SUBJ STATES "PAUL" HAS BEEN HUSBAND'S CASE OFFICER SINCE BEFORE SHE ARRIVED GDR NOV 56. AGE CIRCA 40, HEIGHT 175, THIN FIGURE, LIGHT BROWN HAIR WITH SIDE PART CLOSE CROPPED. LIGHT EYES, TEETH DISCOLORED POOR CONDITION, SPACES BETWEEN UPPER TEETH. RETICENT, SPEAKS POOR GERMAN. SMOKES PAPIROSI HEAVILY. WEARS GOLD WRIST WATCH WITH BROAD GOLD BAND. MARRIED TWO CHILDREN ONE IN USSR. HUSBAND STATES PAUL LIVES KARLSHORST COMPOUND AND IS IN FULL CHARGE ALL HIS OPS. PAUL RECENTLY PROMOTED LT COL IN CONNECTION FORTIETH ANNIVERSARY CELEBRATION.

PAUL USES VIKTOR AS INTERPRETER DURING FOR LOCAL RIS SUPPORT AND LIAISON WITH NER. TWO VIKTOR LEIPZIG MEETINGS WITH SUBJ HUSBAND. HUSBAND USES VIKTOR DOES NOT GIVE DIRECTION. VIKTOR AGE 48-50, HEIGHT 165, GREY HAIR, POOR MARKED FACE, FAULTY TEETH. MARRIED, WIFE'S NAME ENMI. FAMILY ARRIVED FROM USSR THREE MOO AGO. VIKTOR WAS LAWYER IN USSR AND WAS FORMERLY STATIONED IN EBRLN.

3. HUSBAND OPS TARGET WAS UPSWING IN MUNICH AREA. SUBJ AND 17 YEAR OLD SON STATE HUSBAND HAD NUMEROUS TOWN PLANS MUNICH ON DESK AND MAIN INTEREST WAS IN PERSONS FROM THIS AREA. IN ADDITION PERSONS MENTIONED REF FOLL PLAYED ROLES HUSBAND OPS ACTIVITIES:

A. DOCTOR "OTTO" (COVER NAME) RESIDENT MUNICH AREA WHOM HUSBAND MET PRIOR SUBJ ARRIVAL GDR AT ANTIFA OFFICERS REUNION EBRLN. HUSBAND DEVELOPED AND RECRUITED OTTO WHO KNEW HUSBAND TRUE NAME. OTTO FLIES EBRLN AND HAS EBRLN MEETS WITH HUB APPROX ONCE PER MONTH TO PROVIDE INFO UPSWING IN MUNICH. HUSBAND SATISFIED THIS INFO AND CASE PROGRESS UNTIL APPROX THREE WEEKS AGO WHEN SOVS TOLD HIM OTTO DOUBLE AGENT FOR "MUENCHEN AMT FUER VERFASSUNGSSCHUTZ". RIS DISCOVERED THIS THRU THEIR PENETRATION AGENT IN "SAME DIENSTSTELLE". HUSBAND TOLD SUBJ RIS INTENDED LET OTTO MAKE COUPLE MORE MEETINGS THEN DETAIN EBRLN.

B. FRAU MARTIN FNU-SECRETARY FOR HUSBAND NEWSPAPER MITTELDEUTSCHE NEUESTE NACHRICHTEN, THOMASBUS STR 2 LEIPZIG. BELIEVES HE WITTING RIS ACTIVITY ONCE LENT HER ROOM TO HUSBAND FOR USE BY BERGER DURING LATTER'S TRIP LEIPZIG.

C. DORENZ FNU (POSSIBLY ERIC). OPS PSEUDONYM SCHMIDT OR MORE PROBABLY SCHULZ. PRO BICYCLE RACING TRAINER WHO RESIDES STALIN ALLEE HALLE ACROSS FROM VED KAROSSERIE BAU (ALSO RECEIVED DAROSSERIE BAU). MARRIED, WIFE FORMER PRISONER.

D. LUHN-ERDMENGER FNU DAMEN FRiseur, NORDHAUSEN/HARZ, GDR KARL MARX STR 6. HUSBAND RECEIVES LETTERS IN NAMES KOWALSKI AND PFEIFFER FROM LUHN AND VISITS LUHN APPROX ONCE PER MONTH. SUBJ BELIEVES LUHN ALSO VISITS FEDREP FOR HUSBAND.

E. FNU MARX, CHIEF REFUGEE CAMP EISENACH WHERE PERSONS FLEETING FEDREP TO GDR SCREENED. MARX PASSES LISTS ALL PERSONS FROM MUNI AREA TO HUSBAND FOR LATER INTERROGATION.

F. FRAU FNU SCHWEDT, WIDOW, MAX SIMON'S SECRETARY ALSO EMPLOYED BY RIG AND PERFORMS SECRET SECRETARIAL WORK FOR HUSBAND.

G. FNU ZEITHAMMER AND WIFE (SECOND WIFE). REFUGEES FROM BAVARIA WHO SETTLED LEIPZIG THRU HUSBAND INTERVENTION. IN FEDREP ZEITHAMMER WAS PART OWNER FIRM SPECIALIZING SANDSTONE, ORNAMENTAL STONE, ETC. PARTNER CHEATED HIM, 2 YEARS TO SPEND JAIL SENTENCE.

H. FNU KOEHLER OWNER TRANSLATION BUREAU LEIPZIG OF SAME NAME. HUSBAND PICKED UP UNKNOWN MATERIAL FROM KOEHLER FOR PASSING TO SOVS PARTICULARLY DURING LEIPZIG FAIRS.

 - A. INFO RE BERGER ADDRESS TAKEN FROM BUSINESS CARD WHICH SUBJ SWITCHED FROM HUSBAND. BERGER SENT TELEGRAMS TO SUBJ AT NEWSPAPER STATING AWAIT YOU MUNICH WITH DATE AND TIME. THIS CODE INDICATING MEETING SET FOR EAST BERLIN BETWEEN BERGER AND HUSBAND. BERGER PSEUDONYM SCHWAB GIVEN HIM BECAUSE HE SCHWABIAN. HUSBAND MAIN INTEREST WAS IN BERGER CONTACTS AND FRIENDS IN URBANING.
 - B. SUBJ GOT SCHROETER NAME AND ADDRESS FROM "AUFENTHALTSGENEHMIGUNG" S USED TRIP GDR 2 JAN THRU 5 FEB 56. SUBJ TOOK DOCUMENT FROM SUBJ DESK. SUBJ BELIEVES HUSBAND INTIMATE WITH S AND THIS NOT JUST BASED ON FACT S USED LOVE THEME IN OVERT TEXT HER OPS LETTERS. S WROTE TO HUSBAND IN ALIAS MURT PFEIFFER FOUR-LAGERND C-17, POSTAMT HAUPTBAHNHOF LEIPZIG. S FATHER WEISSENFELS OLD COMRADE AND WITTING PARTICIPANT THIS OP.
 - C. SIMON ALSO MEMBER OR FUNCTIONARY NDRP. TOLD SUBJ HE WORKING FOR TOWNS FOR MATERIAL REASONS ONLY.
 - D. LAMPE SPOTTED WHEN AS OWNER SMALL PRIVATE BREWERY APPEALED SINCE AS DIRECTOR HANDELSKAMMER PROTECT HIM AGAINST AUTHORITIES WHO WANTED NATIONALIZE BREWERY. SIMON TURNED HIM OVER TO HUSBAND WHO FIXED DIFFICULTIES AND REORGANIZED
