1. SUBJ TRANSFERRED BOB SAFEHOUSE APPROX 1600. ALIAS EMMERICH NOTIFIED APPROX 1730. EMMERICH REQUESTED WE RETAIN SUBJ OUR SAFEHOUSE AT LEAST OVERNIGHT. SINCE SUBJ EXTREMELY COOPERATIVE HAVE BEEN INTERVIEWING REGARDING PERIOD NOV 56 UNTIL DEFECTION FOR INFO CONTAINED REF.

2. SUBJ STATES MAJOR REASON SHE LEFT FEDREP TO JOIN HUSBAND WAS FINANCIAL. ALTHO UPSWING FINANCIAL ASSISTANCE APPARENTLY GENEROUS FOLLOWING HER EVACUATION FEDREP FROM WBRLN 1953 THIS STOPPED AFTER RESETTLEMENT COMPLETED. SUBJ RECEIVED PENSION STEMMING FROM HUSBAND PRIOR POLICE SERVICE BUT THIS STOPPED WHEN FEDREP AUTHORITIES LEARNED HUSBAND GAINFULLY EMPLOYED GDR. SUBJ CLAIMS SHE APPEALED DIRECTLY UTILITY BUT TOLD NOTHING COULD BE DONE.

3. SECONDARY REASON GOING GDR WAS HOPE SHE COULD FOR SAKE CHILDREN RECREATE SATISFACTORY HOME LIFE. AFTER YEAR SUBJ SAW NOT POSSIBLE AND WHEN SHE BECAME AWARE HUSBAND TRUE SOURCE INCOME SHE THREATENED LEAVE. SUBJ STATES HUSBAND DID NOT BELIEVE HER BECAUSE HE FELT THAT IN COMING GDR SHE TOO HAD BURNED BRIDGES. SUBJ STATES HUSBAND INVETERATE BRAGGART WHO GOES AS WIND BLOWS. RIS HAS NO IDEA

EXTENT SUBJ KNOWLEDGE HUSBAND'S OPS ACTIVITIES SINCE HE NOT AUTHORIZED TELL HER ANYTHING. SHE FOUND OUT BY RUMMAGING IN HUSBAND'S PAPERS, COMING UP WITH VARIOUS DOCUMENTS AND ACCUSING HIM LOVE AFFAIRS, ESPIONAGE ETC. SUBJ MADE DISCLOSURES PARTLY TO DEFEND HIMSELF, PARTLY BECAUSE VANITY, URGE APPEAR IMPORTANT.

4. SUBJ DEPARTED LEIPZIG 8 NOV WHILE HUSBAND AWAY. SHE LEFT FAREWELL NOTE AND TOOK TRAIN EBRLN UNDER COVER VISITING SISTER WHO LIVES THERE. FAMILY LUGGAGE CHECKED THRU TO SISTER BY BAGGAGE CAR. ONCE IN EBRLN LUGGAGE MOVED PIECEMEAL TO WBRLN BY SISTER WITH HUSBAND EMPLOYED CHARITE.

5. SON RECEIVED LETTER FROM GIRL FRIEND LEIPZIG 15 NOV STATING HUSBAND SEEN FRANTICALLY COMING LEIPZIG IN SEARCH FAMILY. SUBJ DOUBTS IF HE WILL TELL HIS FAMILY GONE AT FIRST. APPARENTLY IN EFFORT TAKE OUT INSURANCE AGAINST SUBJ POSSIBLE DEPARTURE HUSBAND HAD BEGUN SPREAD RUMORS WIFE MIGHT HAVE NERVOUS BREAKDOWN, WOULD NEED REST AND VACATION AWAY FROM LEIPZIG.

6. WHILE SUBJ NOT FULLY DEBRIEFED BY ANY MEANS APPARENT SHE NOT VERY MUCH MORE KNOWLEDGEABLE HUSBAND'S ACTIVITIES. BELIEVE EXCELLENT CHANCE EXISTS LURE HUSBAND OUT WITH LETTER MAILED TO SON'S GIRL FRIEND CONTAINING PITCH ALONG INTEL LINE'S COUPLED WITH COVER LETTER FROM WIFE STATING SHE WELL RECEIVED, ETC. BELIEVE
