1. CAVATA INFORMED ODOPAL REP HERE FOLLOWING 4 DECEMBER. WIFE OF FORMER UPSWING AGENT WHO DEFECTED TO DDR SOME TIME AGO RECENTLY RETURNED FEDREP AND CONTACTED UPSWING TO REPORT ON ACTIVITIES HER HUSBAND FOR MFS. WIFE APPARENTLY DENOUNCED HUSBAND AS RESULT MARITAL DIFFICULTIES. AMONG OTHER THINGS, WIFE TOLD UPSWING THAT HUSBAND IN CONTACT FORMER SS GENERAL GOTTLLOB BERGER, RESIDING STUT, CHIEF OF SALES DEPT OF MHZ (SIC) HACHDEL AND COMPANY. WIFE ASSUMES BERGER ALSO WORKING FOR MFS.

2. UPSWING REPORTED BERGER INFO TO FEDERAL PROSECUTOR AND CAVATA, TELLING LATTER THAT BERGER MAY BE AIS SOURCE. CAVATA THEN ASKED PROSECUTOR DELAY ARREST BERGER UNTIL POSSIBLE AIS ANGLE CLARIFIED.

3. NO BASE TRACE BERGER. HOWEVER, CASTIRRUP REQUESTED US EXTRACT INFO ON BERGER FROM NUERNBERG TRIAL RECORDS AROUND 27 NOVEMBER [] BELIEVES FORMER UPSWING AGENT PROBABLY WOLFGANG HOEHER.
