To Mr. Morrison

Since I am "busy" at the moment and thus unable to leave here and since the subject is so urgent, I am sending this most important matter by courier for safety.

The American affair seems to go further and to assume increasingly greater proportions so that I must ask you and Mr. REED to take over from here. On 7 Oct 62 at about 1700 there came in LIMA, before Land Secretary Walter REISINGER, Mr. MERTON who introduced himself as a member of the CIC in LIMA and who further alleged that he came from the "Berufschule des Just" of the S Secret Service. The American warned REISINGER very considerably against his co-worker Theo WILHELM, the publisher of the information service of the UVP in Upper Austria. He explained that he received his information, mostly about the UVP, from WILHELM, said information being always false. He knows from his information in the SK of the UVP how the SK known absolutely all connections. For this reason he can only warn urgently against WILHELM and his UVP. It is further known in the SK that WILHELM works together with Dr. HUGL, DR. KREUZER, and DR. WERNER BILLY. These are all "bad boys" who are swimming in money and who are discredited by the Nazis. WILHELM is particularly hated by the Nazis because of his testimony at NUREMBERG. He works with the Americans and the UVP but not with the Left. His closest coworker is said to be Nationalrat GRIESINGER even though he is said to have worked with this man over the division of the huge UVP boot in Altluarzo.

I do not know the name of the American. I could only say which that on his day two (2) Americans were with REISINGER, named SMITH, the other FREUDINGER. Whether it was either of these two, I do not know.

If only the situation were so stupid that one didn't have to watch it. In particular I'm going to judge in reproach which, besides being stupid, most always contradict themselves. However, as an American Officer working overseas to me to be very important a warning or consideration. This I will press in the following:

1.) Is there an "informant" of the US secret service? If so, that I can't believe is, that this man (in whom was not only trust) gave out such service secrets as to facilitate his country to punish him.

2.) If the man was from another American organization, he revealed service secrets in a deplorable manner, for the confessions of the persons he told about had not been known to live in the US at that time. Since, as far as I know, no outsider can know who belongs to the group, this can only concern a man familiar with the inner affairs of the group. Thereby I am brought forcibly to R. W. MILLER. This suspicion is supported by the fact that he played the same role in the USSR case.

3.) Next to R. W. MILLER it could be Hermann, alias Dr. SCHMIDT (in reality he is Hermann WILLEMER and lives in GERMANY). He was summoned by you the other day and who is a friend of R. W. MILLER's for whom he pulls strings on occasion.

I hope that this misdeemeanor will be the last for him, because the situation is not only extremely unpleasant for us but also for our common work. WILLEMER is known as one of our best and most trustworthy co-workers. Because of his bad connections he is hardly available. WILLEMER is a well-known socialist and has not only links all the material of the KVP in Germany but also those he is supposed to be furthering our interests in the Soviet Union and so on. Without naming it we may say

Now to other matters, which are also urgent. You will remember the case on which I have to you or Dr. LUCID with the remarks that they had to do with the best KP experts of the at that time Austrians and also later the German Gestapo. Now I get a report from Vienna. The Russians write me that the Russians made an attempt to get hold of him because they require him as a witness. The Austrian court refused on the pretext that an accusation has already been made against him. Now he fears that the Russians will extradite him and get him to trial when the court no longer has a pretext or after he has served his time up on the present sentence. He has therefore suggested that his trial be transferred to LINZ since most of the witnesses on his side do not dare to testify in Vienna because of the exceeded reprisals. I request once more that something be done quickly for this man (it concerns Kriminalrat Hans SANITZER) before it is too late. I believe that the way indicated by him is feasible since the Austrian Minister of Justice is inclined favorably toward the Act. Otherwise I suggest that SANITZER and the others be transferred to LINZ immediately after his trial on the pretext that they are needed as witnesses for another trial, for instance, that of the SAJETZING Gestapo Leader, Dr. Hubert HÜCKER, whose case is in LINZ for trial and whom I specified in due time as the fourth man. Should it naturally be possible to achieve this transfer before the trial, it would be so much the better. I only fear that it is too difficult, while the other way would be definitely practicable, only we must be prepared so that after the trial the Russians are not quicker than we are. The three people who are in Vienna in Landesgericht I and who have already received their indictments, are: the above mentioned Hans SANITZER, Oberregierungsrat Dr. Karl EWERT, and Oberregierungsrat Dr. Othmar FREYER. Please lay this matter immediately before Dr. LUCID.

Now to the HEIMATKUF affair. After the step of the British High Commissioner, it could no longer be saved. Apparently its American colleague didn't try any more. The matter has gone wrongs for us. Now I should like a chance to get such a newspaper for us and thereby start a paper in LINZ, a matter about which I already told you, in order to aid in getting our work in hand. That will be possible if HEIMATKUF, through you, regains confidence in me. As soon as I learn that it is again OK with him, I will undertake this task. Today I have only a purely humanitarian duty to perform. This is that the publisher, Franz KLÄUTZER, be set free again. He owes his arrest and his ruined newspaper exclusively to the fact that

Secondly, and last, also the personal side of it is important for me and two others, which fact is obvious because through this, most unpleasant contact could develop between us and the Austrian authorities, entirely aside from attacks by the Communists and their agents. For the moment it seems to me to be best to save RISINGER and his wife for the work in which connection I suggest the following steps which must be agreed to by you.

RISINGER must have an understanding with CIC LIRE about this matter -- in view of his position possibly directly from Mr. HARRIS -- so that he can justify himself on the entire affair. You ought to be explained to him that his alleged American visitor is an Inspector. It should be shown that the mentioned Gentlemen, Mr. W. E. HARRIS, Mr. COOPER, and MR. MCNAUL, are completely reliable and honest persons. The statements of the alleged American about the ZK or the FBI were fictitious. Only if RISINGER immediately gets the conviction lifted, he was not deceived by me and that I am a reliable man with good connections, can he possibly be saved for the work. It is not so important to me at the moment that I be reinstated but it is important that the situation be corrected. Now you carry out your investigations, you certainly know better than I but I believe, however, the rail will soon lead to Mr. ALEXANDER.

he and we believed. You and Mr. LUCID will understand, as officers, that it is incompatible with my honor not to try to do all in my power for KLAUTZER so that he at least regains his freedom. The terrible loss of this entire affair is unimaginable. The *WELT* was attacked by SOUCIK and other comrades because of KLAUTZER's associations with the CRAZED KOWARIK and finally for this reason it was banned because no substantiation was presented for the neo-Nazi writings. The only man who was compromised by SOUCIK was the publisher STOCKER. It was known that the man wanted the *HEIMATRUF* to work for the SPÖ, that is, that the *HEIMATRUF* should mediate the nazi voice for the Reds. Therefore we dismissed STOCKER from the newspaper. And now, since the *HEIMATRUF* was banned, comes the greatest insolence; the trial of STOCKER on charges of nazism was begun! All the reliable people of the newspaper are either locked up or have lost their livelihood. The editor-in-chief, Dr. Manfred JAGG, is now in LIND at my request so that nothing can happen to him. He will help us start the new newspaper and bring to us the subscribers from the *HEIMATRUF*. (As an unsurpassed optimist, one can see an advantage in all, even in the fact that the *HEIMATRUF* is now finally dead and we therefore can begin a new newspaper all alone without unknown persons being able to look in on what would be of great importance in regard to the intelligence net achieved through the newspaper. However, as said before, please do everything for KLAUTZER, if not on humanitarian grounds, for this reliable, brave, front-line officer, who is innocent, deserves as much, than on the basis of ethical duty because he has believed in our help and has dared all in this belief.)

Lastly, one more question: Are the permits for KOWARIK and me there?

I will call you again at the end of the week, by that time you will probably see more clearly, into the RESINGER affair, above all. Otherwise, please give news to Ing KOWARIK if you want to get in touch with me. With the best of wishes, I remain
