SPECIFIC: Meeting with

1. This case officer met in Salzburg the evening of 10 November 1949.
2. reported that he is investigating the activities of Wilma Valentine GOESS living at 25 Fialaplatz, Linz, who is suspected of being connected with OSIA in Vienna (see SLZ/1997). Thus far, it has been established that the GOESS family have no visible income; Wilma GOESS leaves her apartment rarely but receives occasional visitors whose identities so far have not been established. She is related to one of the owners of the Hotel and Lager Industrieverwaltungsges. in Linz and visits their offices occasionally at Promenade 20. The firm's telephone numbers are 21245 and 24247; Wilma GOESS' telephone number is 24245. promised to report on his additional findings at our next scheduled meeting in Salzburg the evening of 23 November 1949.
3. was requested to furnish additional information on the activities of SCHMANN (see SLZ/1997). He stated, however, that because of unfriendly relations between the Sicherheitsdirection of Upper Austria and of Land Salzburg, he is unable to investigate cases in Land Salzburg. could be requested to do this for us.)
4. Re. the activities of Wilhelm SCHNEIDER remarked that SCHNEIDER and Dr. KERNBERGER (see SLZ/1997) are seemingly no longer connected with SIC, Upper Austria. He based his belief on the fact that KERNBERGER is now seeking a smaller modest apartment and that both men are presently seeking business opportunities or employment.
5. Attached please find raw reports on which I am unable to comment.
6. office obtained a map, dated 20 June 1949, marked "Abgrenzungskarte 4758 Vojensky Ezeriansky Satov, Praha 1:75000" from Bratislava through a Czech SP name SCHNEIDER who is allegedly a relative of Gen. SANCHEZ. promised to borrow the map so that it can be photostated.

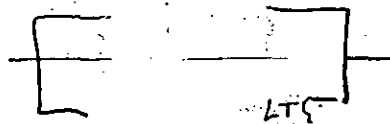
