4. REPORT OF FINDINGS

The following information was received by the undersigned on 21 January 1952 from the Italian Consul, PAASCARELLI, (Evaluation: "F"), located at Hauspurgstrasse 39, Salzburg. (Informative: 2)

PAASCARELLI stated that his office had information to the effect that Wilhelm HOETTL (believed to be Wilhelm HOETTLE), born 19 March 1915, presently residing at Bad Aussee, Austria, is a suspected Soviet agent who travels between Austria and Italy. PAASCARELLI further indicated that HOETTLE was in contact with a Dr. Adolf SLAVIK, also believed to be a Soviet agent and who is a member of a group of former Concentration Camp inmates.

PAASCARELLI requested that someone who was familiar with the case of HOETTLE and/or SLAVIK discuss the various aspects of the case with him. It was pointed out by PAASCARELLI that HOETTLE could be dangerous to both the Italians and Americans and in particular the Wagner Project.

FILES CHECK:

The files of this Sub-Attachment contain numerous references concerning Dr. Wilhelm HOETTLE, identical with the Wilhelm HOETTL, mentioned above, as an intelligence operator.

The files of this Sub-Attachment contain numerous references concerning one Dr. Adolf SLAVIK, mentioned above, as the leader of the National Liga.
