<p>14. HOETTL, WILLI (DR) [] SUBJ (KARL HEINZ MORAWEK) ADVISED THAT HE FIRST MET HOETTL NEAR THE END OF WORLD WAR II WHILE THEY WERE BOTH MEMBERS OF GERMAN INTELLIGENCE. AT THAT TIME HOETTL HELD THE RANK OF SS STURMBANNFUEHRER (MAJOR) IN THE SD (SICHERHEITSDIENST - SECURITY SERVICE) WHILE SUBJECT WAS A UNTERSTURMFUEHRER (2ND LIEUTENANT. AT ABOUT THE SAME TIME HOETTL, WHO WAS ALLEGEDLY BACKED BY A GROUP HEADED BY GENDARMERIE GENERAL KALTENBRUNNER, WAS ALLEGEDLY IN CONTACT WITH THE BROTHER OF JOHN FOSTER DULLES IN SWITZERLAND. THIS GROUP WANTED TO SURRENDER TO THE AMERICANS. THESE NEGOTIATIONS WERE BEING CARRIED ON WITHOUT THE SANCTION OF THE GERMAN HIGH COMMAND, AND ACCORDING TO SUBJECT, "HOETTL ALMOST LOST HIS HEAD OVER IT". JUST PRIOR TO THE TIME THESE NEGOTIATIONS CAME TO AN END HOETTL HAD INFORMED SUBJECT THAT HE WAS TO BE SENT TO SWITZERLAND AS A COURIER TO CONTACT DULLES. SUBJECT NEVER MADE THIS MISSION BUT SINCE THAT TIME THERE HAS EXISTED A SORT OF FRIENDSHIP BETWEEN SUBJECT AND HOETTL. THIS FRIENDSHIP WAS NOT FORMED ON THE BASIS OF TWO (2) EQUALS BECAUSE, AS SUBJECT POINTED OUT, "HE WAS BELOW HOETTL'S STATION IN LIFE", BUT ADMIRER HOETTL AND CONSIDERED HIM TO BE AN INTELLIGENT MAN. HE LATER ASSISTED HOETTL IN THE PREPARATION OF HIS BOOK TITLED "DIE GEHEIMFRONT" (THE SECRET FRONT). SUBJECT ADVISED THAT HE HAD NOTHING TO DO WITH COMPOSING THE BOOK; HOWEVER AT HOETTL'S REQUEST HE DID MUCH OF THE TYPING AND EDITING.</p>
