On 25 January 1964, Informant 3848 reported to this Agent that the Austrian State Police, Salzburg, Land Salzburg, had received the following information from a confidential informant: Dr. Wilhelm HOETTL, born 19 March 1915 in Vienna, Austria, residing in Alt Aussee, Land Styria, Austria, stated to Informant that he had been prohibited entry into Germany from Austria as an undesirable. SUBJECT stated that he wrote a letter of complaint to the Commanding General of the US Sector of Germany, and the ban was lifted about three months later. SUBJECT stated that Allan Dulles, the brother of the US Secretary of State, and Senator McCarthy intervened for him, since he had some connections with them. (C-3)
